## EXHIBITION TERMS & CONDITIONS

### 1.0 CLASSIFICATION

- 1.01 The Organiser: Younie Gallery Sdn Bhd;
- 1.02 Title: “**ART ASIA@KL 2018 HOTEL ART EXPO**”;
- 1.03 Exhibition Period: **6 September 2018 till 9 September 2018**;
- 1.04 Exhibition Venue: **Palace of The Golden Horses, Jalan Kuda Emas, Mines Wellness City, 43300 Sri Kembangan, Selangor Darul Ehsan, Malaysia**;
- 1.05 Exhibitors Categories: Solo artists, Fine Art galleries, Designer Jewelleries, Sculptors, Handcrafters or Art Companies;
- 1.06 Exhibit: Modern and Contemporary original fine artworks, Modern and Contemporary sculptures, genuine and designer jewellery, etc;
- 1.07 Exhibit Booth: Hotel rooms allocated by the organiser to the Exhibitor. Room type is Dignitaries Deluxe of size 40sqm. You may view the room on the hotel website for reference:

- 1.08 Move-in time: Check-in Booth as hotel guest on 5 September 2018 from 3.00pm. All exhibits must be ready for showcase by 11.00am on 6 September 2018 (Thursday);
- 1.09 Dismantling time: 9 September 2018 from 7.30pm onwards;
- 1.10 Check-out time: 10 September 2018 (Monday) on 12.00noon;

### 2.0 REGISTRATION

- 2.02 The Organiser has the sole discretion to reject or approve any registration, allocate or reallocate the Booth;
- 2.03 Full payment is required to reserve the space on or before **15 July 2018**;
- 2.04 The Exhibitor secures that all the information provided in the registration is genuine and its exhibits are original;
- 2.05 The Organiser reserves every right to revoke any participation if the information provided in the registration form is false and the Exhibits are unoriginal, or not artist's own creation of works;
- 2.06 All payment will be forfeited in full if the above (2.05) circumstances occurred;

### 3.0 PAYMENT

- 3.01 Cost per Booth is **MYR10,000**;
- 3.02 Payment payable to Younie Gallery Sdn Bhd. **Please contact the office for account details before remittance**;
- 3.03 Payment methods: Money order, bank draft, company cheque or telegraphic transfers. Exhibitor should email the remittance slip to the Organiser as acknowledgement;
- 3.04 Payment is not refundable or will be forfeited if participation is withdrawn after 31 July 2018;
- 3.05 All payment will be forfeited in full if the Exhibitor fails to occupy its Booth by the Move-in time. The Organiser reserves all rights to rearrange the Booth at its absolute discretion;

### 4.0 EXHIBITS AND ELIGIBILITY

- 4.01 The Exhibitor has to ensure that the Exhibits abide by all rules, regulations and requirements by local Authorities, not touching on sensitive, racial and religious issue, nudity or images presented with vulgarity, obscenity or of provocatively sexual in nature;
- 4.02 The Exhibitor is required to provide information on sales of Exhibits, as the Organiser needs to evaluate the annual growth of the Exhibition;

### 5.0 “ART ASIA@KL 2018 HOTEL ART EXPO” CATALOGUE

- 5.01 The Exhibitor will be entitled to two complimentary content pages in the catalogue;
- 5.02 The Exhibitor is required to submit the information of the pages for the catalogue before or on 31 July 2018;
- 5.03 The Organiser reserves the right to edit the contents submitted by the Exhibitor for conciseness for the catalogue;
- 5.04 The Organiser reserves the right to use the artwork images for publicity and promotional purposes for the event;

### EXHIBITION TERMS & CONDITIONS

#### 6.0 BOOTH (ROOM SETTING)

- 6.01 Exhibitor is not allowed to nail or add on any hooks on the wall to hang the exhibits in the hotel room during Move-in Time. Event crews will be available for assistance during installation;
- 6.02 Captions or explanatory pieces for Exhibits are to be provided by the Exhibitor;
- 6.03 The Exhibitor is not allowed to display or distribute any Exhibits other than the products specified in the participation form;
- 6.04 All Exhibitors and their assistants must wear badges during the exhibition hours;

#### 7.0 DISMANTLING OF EXHIBITS

- 7.01 All Exhibits must be removed before Check-out time (10 September 2018 before 12.00noon).
- 7.02 Exhibitors are not allowed to delay their stay unless they bear the full cost of the room to the hotel on normal rate basis;

#### 8.00 SECURITY

- 8.01 As hotel guest, the Exhibitor will receive general security service provided by the hotel;
- 8.02 No Exhibits are allowed to be brought out from the event hall without filling up the Exhibit Exit Form at the Organiser Office;
- 8.03 The organiser shall not be liable for any loss or damage of any article;

#### 9.0 SAFETY & INSURANCE

- 9.01 The Exhibitor is responsible for full insurance coverage against all risk on its Exhibits, properties and injury to person during the Exhibition, Move-in Period and Dismantling Period;
- 9.02 The Organiser shall not be liable for any loss or damage suffered by the Exhibitor;

#### 10.0 EXCLUSION OF THIRD PARTY RIGHTS

No person other than the Exhibitor and Organiser shall have any right under the Contracts (Rights of Third Parties) Act to enforce any of these terms.

#### 11.0 FORCE MAJEURE

The Organiser shall, upon the occurrence of events beyond its control including, but not limited to, act of God, fire, storm, tempest, lightning, flood, natural disaster; national emergency, war, labour disputes, strikes, lockouts, civil disturbances, economic or political unrest; explosion, destruction, damage to property, unforeseeable accident; epidemic, have the sole and absolute discretion to cancel, postpone or shorten the duration of the Exhibition. In such circumstances, the Exhibitors shall not be entitled to any refund or compensation, whatsoever.
