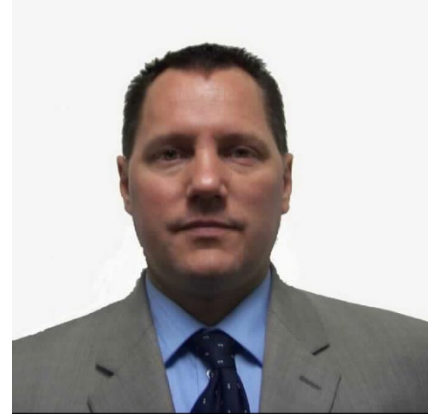


David M. Kohl

*Deputy Supervisory Air Marshal in Charge
Joint Coordination Center*

David Kohl joined the Federal Air Marshal Service in May of 2002. In October 2010, he was assigned to the Joint Coordination Center (JCC). Mr. Kohl is a Deputy Supervisory Air Marshal in Charge (DSAC) responsible for assisting, developing and managing the TSA's Visible Intermodal Prevention and Response (VIPR) program and the JCC located at the Freedom Center. He is accountable for coordinating of communications between Office of Law Enforcement (OLE), Office of Security Operations (OSO), Office of Security Policy and Industry Engagement (OSPIE), and Office of Chief Counsel (OCC) as they related to VIPR Operations.



From August 2007 through October 2010, Mr. Kohl was assigned the position of Assistant Federal Security Director for Law Enforcement at Reagan National Airport. He had been charged with establishing and maintaining liaison relationships with local, state and federal law enforcement authorities on behalf of TSA and to coordinate their activities within the transportation domain. He is the TSA-DCA coordinating point in support of investigations being conducted within the airport environment by other law enforcement agencies.

In his previous position he was an Assistant to the Special Agent in Charge assigned to Washington Field Office (WFO), Mr. Kohl was charged with the supervision and management of 20 Federal Air Marshals (FAMs) who were also assigned to the WFO. Mr. Kohl's career with the FAMS began at WFO, where he spent the first six (6) months in flight status before being selected for the Liaison position at Dulles International Airport. He returned to flight status after successfully completing his rotation as Liaison before his promotion to ATSAC in October 2005.

Prior to joining the Federal Air Marshal Service, Mr. Kohl began his career in law enforcement in July 1991 with the Secret Service, Uniformed Division. In September 1997, he was promoted to the rank of Sergeant, and transferred to the White House Branch. He had served at the Foreign Missions Branch (FMB) and the White House Branch (WHB) during his eleven years.

Mr. Kohl holds a Bachelors degree in Management from National Louis University, Washington DC.

Michael holds a bachelor of science degree from Empire State College.
