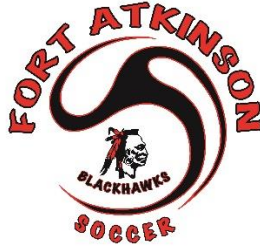
The last 30 minutes, we will talk about the season, cost and expectations.
