Please check the box on your dog's entry form if you are eligible and wish to enter this special **Owner-Handled Best of Breed** competition.

Online entrants – Please check the Owner Handler Eligible box, or write 'NOHS' in the Additional Classes box.

Dogs must be handled throughout the breed level competition for the regular show by an eligible owner.

BOXER PUPPY – JUNIOR SWEEPSTAKES

Entry Fee is \$25.00 – Saturday AM show only. All entries in Sweepstakes must also be entered in a regular class in the AM show. Entries shall be made at the same time on the same entry form used for the regular class. **“Sweepstakes” and “age” division must be indicated in the space for Additional Classes on the official AKC entry form.**

This Sweepstakes is open to all Boxers who, on the day of the show, will be six (6) months and under eighteen (18) months of age. Sweepstakes classes will be judged prior to the regular breed classes.

The competition will be divided into six classes as follows:

PUPPY CLASSES

Puppy Dogs, 6-9 mos.

Puppy Dogs, 9-12 mos.

Puppy Bitches 6-9 mos.

Puppy Bitches 9-12 mos.

JUNIOR CLASSES

Dogs, 12-18 mos.

Bitches, 12-18 mos.

The BEST PUPPY shall compete against the BEST JUNIOR, and the winner shall be designated GRAND SWEEPSTAKES WINNER.

1st Place thru 4th Place winners will receive a crate blanket.

Thirty-five percent (35%) of total receipts will be retained by the Club for expenses.

Sixty-five percent (65%) of total receipts is to be divided among the winners as specified below:

Sixty percent (60%) of the sixty-five percent (65%) will be divided equally among the 1st Place winners of each class.

Forty percent (40%) of the sixty-five percent (65%) will be divided as follows:

BEST PUPPY IN SWEEPSTAKES25%

BEST JUNIOR IN SWEEPSTAKES25%

GRAND SWEEPSTAKES50%

Cash prizes will be paid in the ring to the person handling the dog, which will be considered the rightful recipient of the award. Claims for prize money must be made in the ring before the Sweepstakes judging is over. The show-giving club disclaims any liability for cash prizes after judging is complete. Any prize money allocated but not awarded shall be returned to the Club treasury.

FOUR TO SIX MONTH PUPPY COMPETITION

Entry fee is \$20.00. The BCOA will offer this competition on Saturday & Sunday.

Entry can be made using the regular AKC Entry Form. Please designate “4-6 Month” in the Dog Show Class box. The AKC Litter Registration number can be used. The 4-6 Month Puppy Class will NOT be divided by sex. A Best of Breed and Best of Opposite Sex will be selected from the entrants in the class.

Please Note: *Per AKC Rules, no Professional Handler will be allowed to exhibit in this class, even if they are the breeder or owner of the puppy.*

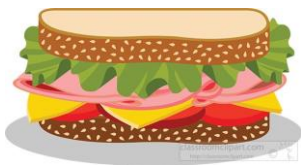

DIRECTIONS TO THE SHOW SITE

From I-10: Take I-10 to US 60 East. Take Exit 182 for Gilbert Rd. Go North on Gilbert for 2 miles. Turn Right (East) onto Southern Ave. Turn North on Lindsay Rd and go appx 6 ½ miles. Royal Arabians will be on your Left.

From I-17: Go South on I-17 to Loop 101 East exit. Continue on Loop 101 to Loop 202 East exit. Proceed on Loop 202 for appx 6 miles. Take Gilbert Rd exit and proceed South on Gilbert. Turn Left (East) on McKellips Rd. Turn Right (South) onto Lindsay Rd. Royal Arabians will be on your Right.

ALL ENTRIES WITH FEES MUST BE IN THE OFFICE OF THE SHOW SECRETARY NOT LATER THAN

12:00 Noon – WEDNESDAY – MARCH 10, 2021

after which time no entries may be accepted, canceled, changed, substituted, corrected, or signed and no entry fees refunded. Telephoned and telegraphed entries are not accepted. All changes and cancellations must be received in writing prior to closing, except as provided for in Chapter 11, Section 6 of the American Kennel Club Dog Show rules.

THIS SHOW is governed by The American Kennel Club. Exhibitors should read the AKC agreement on the back side of the entry blank in this Premium List.

ENTRIES NOT ON OFFICIAL AKC ENTRY FORMS and Photocopies of entry Forms without Agreement and Rules on the reverse side of the official AKC Entry Form are NOT ACCEPTABLE.

NO ENTRY CAN BE ACCEPTED that specifies any conditions as to its acceptance. Telegraph or unsigned entries cannot be accepted. Owners are responsible for errors in making out entry forms, and no entry fee will be refunded in the event of errors after closing date.

ENTRY CONFIRMATIONS & JUDGING PROGRAMS will be e-mailed to all entrants who provide email addresses. All others will be mailed by the USPS.

ALL DOGS PRESENT must be held on leash or confined to their crates except when being judged or when in the exercising ring. There is no provision for unentered dogs at this show.

THE BOXER CLUB OF ARIZONA may decline entries for cause and may refuse to receive or may remove any dog on account of disease, viciousness or any other cause. No one shall have any claim or recourse against the Club or any official thereof.

ENTRY FEES SHALL NOT BE REFUNDED in the event that a dog is absent, disqualified, sick, lame, excused by Veterinarian or Judge, barred from competition by action of the Bench Show Committee, or because the dog is ineligible to compete due to being entered incorrectly.

If, because of riots, civil disturbances or other acts beyond the control of the management, it becomes impossible to open or complete the show, no refund of entry will be made. There is no refund of entry fee for duplicate entry. There will be a \$2.00 fee charged for cancellation of entry prior to closing of entries.

RETURNED CHECKS DO NOT CONSTITUTE A VALID ENTRY FEE. The Show Secretary will add a \$25.00 collection fee to the amount of each returned check. Subsequent returned checks for the same exhibitors may result in their being put on a CASH ONLY basis. The returned check MUST BE MADE GOOD by cash or money order BEFORE the dog will be allowed in the ring.

THE CLUB, ITS SHOW SECRETARY and ROYAL ARABIANS will not be responsible for the loss of or injury to any dog or the possessions of any exhibitor, whether the result of accident or other causes.

It is distinctly understood that every dog at this show is in the care and custody and control of his owner or handler during the entire time the dog is on the Show premises. And, in addition, no responsibility will be assumed for any loss, damage or injury sustained by an owner, exhibitor, handler or spectator. The welfare of an exhibitor's child is the responsibility of the exhibitor. It is expressly understood that exhibitors will exercise control and restraint over their children at all times.

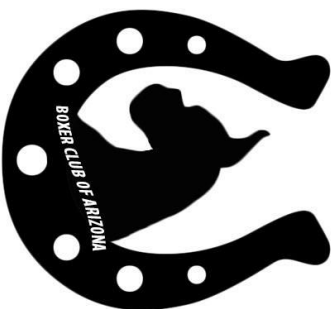
DOGS MAY ARRIVE at any time prior to scheduled time of judging of their class. Dogs not required for further judging will be excused. Owners or handlers alone are responsible for the presence of their dogs in the judging ring. There is no rule of this Club or the AKC that requires a Judge to wait for a dog.

TROPHIES AND CLASS CASH PRIZES will be awarded in the judging ring to the person showing the dog. In the event of any discrepancy from the published prize list, the Show Chairman should be advised at once. All trophies must be claimed the day of the show. None will be mailed.

RECORDING & EVENT FEES: A Recording Fee of 50¢ per dog and an Event Services Fee of \$3.00 will be required for each entry at any Licensed or Member Club Show, Obedience Trial or Tracking Test. These fees are to be collected by the Show-giving Club and paid to the American Kennel Club. (AKC Rule, Ch 11, Sec 2)

TRANSFER OF ENTRY TO BEST OF BREED: Dogs which according to their owner's records have completed the requirements for a Championship after the closing of entries for the Show but whose Championships are unconfirmed, may be transferred from one of the regular classes to the Best of Breed competition, provided this transfer is made by the Show Secretary at least one-half hour prior to the start of the earliest conformation judging at the Show.
