If you know someone who is experiencing a housing crisis, please have them call Centralized Housing Intake at 540-271-1701 to complete an eligibility screening.





World Homeless Day

October 10th

We celebrated, or should I say, brought awareness to the importance of providing safe and livable conditions for people who are experiencing homelessness. Many of the consumers we serve have high barriers and will be forced to live in less than desirable housing units. Recently, I completed a housing inspection at a unit that the landlord said I could "look at any time." There were countless things wrong with this unit that would deem it unsafe for habitation but the most alarming thing was the amount of mold in this unit. We show you these pictures because we want it to be impactful. These are units that some people will be forced to live in because of the amount of barriers that are put in place to keep people out of housing. This unit failed every mark, and it was reported to the local authorities of this town. It is completely unsafe and uninhabitable.







§ 8.01-226.12. Duty of landlord and managing agent with respect to visible mold.

E. If visible evidence of mold occurs within the dwelling unit, the landlord or managing agent with the maintenance responsibilities shall, exercising ordinary care, perform mold remediation in accordance with professional standards.
