Conference Registration and Cancellation Information

The CCIAA/IECIAA conference is Tuesday, September 26, 2017 through Friday, September 29, 2017 in Riverside, CA. The conference hotel is the **historic Mission Inn**; all training is held at this location.

Registration Rates

The pre-conference being held Monday, September 25, 2017 rate for the morning and afternoon session each is \$50.00 USD. The early-bird conference rate is \$350.00 USD. Beginning Friday, August 18, 2017, the rate increases to \$395.00 USD for general registration. Single day registration begins Friday, August 18, 2017, vary in price by day, are limited in quantity and are NON-REFUNDABLE. Your conference registration rate is determined **at the time of your registration**.
