### **Reports**

#### Parks & Recreation:

Bruce Brandon discussed the issue with the board if they have any requests for the Park Guide and does the board have any suggestions for the area surrounding the township hall? It was suggested that maybe something athletic for this area. There was a suggestion for possibly a pickle ball court.

Also discussed was the condition of the stairs at 1st Street. Allan thought that the steps needed new treads instead of new stairs.

Bruce mentioned that Tom Storr's term is up this year as a member of the Park board, he haschosen to not rerun. Tom's position needs to be filled. Allan asked that the minutes reflect the boards appreciation of the service of Tom Storr and David Dobreff for their dedication on the board.

<u>Planning Commission</u> - Barker stated there was discussion at the last PC meeting if the current Zoning Ordinance Book included provisions for a duplex. According to Ellingsen that it did not, except for in the medium density zone. It was suggested to adding the wording to the Ordinances regarding duplexes would be a good idea.

ZBA- There have not been any recent requests.

<u>Water/Sewer Authority</u> - Overhiser reported on the number of mandatory hookups the authority is working with and also the number of new units for October.

<u>SHAES</u>- They will be hiring an additional full time person. Casco's contribution for 2015 is going to increase by 4.68%. The contribution formula for ambulance is based on population and fire is based on taxable value for each of the respective municipalities.

#### **Old Business**

Update on North Shore Drive Drain: The engineers are having trouble getting easements and they may have to redesign the project to adjust for changes.

## **Road Requests**

Request to have columbine resealed and also, Teresa Ruppert turned in a petition last

Springrequesting to have 71st Street worked on given the business of Hawkshead and with the additional traffic. Because of the drain problem on 71st St. between 107th and 105th the south end of 71st St. could be repaired between 105th and 103rd.

For the convenience of the residents of Casco a drop box has been installed in the entryway of the Township Hall. This drop box can be used for tax payments, absentee ballots, zoning/building dept, etc. The township recommends no cash payments in the drop box, they will not be responsible for them.

## Poverty Level Correction-

Overhiser presented the federal poverty guidelines for 2015 for the township board to adopt to be used by the March Board of Review and the Township Supervisor for calculating an applicant's eligibility for a poverty exemption from some or all property taxes. We could stay with the federal guidelines for 2015 which the levels are so low that many that could use some assistance exceed the amounts for eligibility. We can not make the levels lower but we can increase them. Overhiser recommended to raise the poverty guideline to 20%. For an example, a family of four would have to make less than \$28,620 with this 20% increase.

Judy Graff made motion to support the 20% increase of the Poverty Guidelines for 2015. Josiah seconded.
