1. **Consignee** The Consignee agrees that each month \$99 will be charged to their credit card. From the 1st to last day of month. Credit Card forms can be downloaded on www.framesusamiami.com. If forms are not filled and item is not picked up then a \$5 charge per day will be issued. Artwork with a balance fee must be paid in order for artwork to be allowed to leave gallery. Consignee's art or photography will hang from 1st day of month to last day of month. Your photos or art must be in Frames USA & Art Gallery by the 27th day of the month before. _____(initials)
2. **Consignment.** The Artist/Photographer hereby consigns to Frames USA & Art Gallery, those Artworks listed in attached inventory, which is part of this agreement. _____(initials)
3. **Gallery's Commission** The Gallery and the Artist agree that the Gallery's commission is to be 0%, if we don't collect the money. Our goal is for artist/photographers to collect money from Buyer. If artist/photographer/seller designates Frames USA to collect money, a 30% commission fee will be charged. Payment is made within 14 days to consignee. _____ (initials)
4. **Duration of Consignment.** The Artist and the Gallery agree that the initial term of consignment for the Artwork(s) is to follow this contract dates. The consignee has 5 days to pick up their Artwork(s) at Frames USA (6822 SW 40th St Miami, FL 33155 tel.# [305-666-3355](tel:305-666-3355)). All works not picked up as scheduled are subject to a fee of \$5 per day. _____ (initials)
5. **Responsibility for Loss or Damage.** Frames USA & Art Gallery is NOT responsible to any damage or loss to Artwork(s) during the agreed contract period. Artwork(s) handed over to the Gallery are NOT covered under any insurance program. Pieces shall be handed over to Gallery at Artists OWN risk. _____ (initials)
6. **Promotion.** The Gallery shall use it's best efforts to promote the sale of the Artist's Artwork(s). By initialing below, you agree to have images of your Artworks potentially be posted on Social Media, Gallery Website, e-mails, postcards and all types of advertising media. Sometimes credits will be shown. Sometimes credits will not be shown. _____ (initials)
7. All art or photography must be framed and have a way to hang on The Wall. If not, Frames USA will put a frame or wire on back of the piece for a discounted price. (initials)
