I've had a request for a lower alcohol beer so I'm brewing a special bitter. My expected original gravity is 1.044 and 30 IBU's of bitterness. With decent attenuation you should get 4.5%ABV. I hope it will be a decent session beer. If you check the BJCP Guidelines the O.G. is right in the middle of the style, but the bitterness is on the low end. I will post the recipe on the Yahoo group, and submit it to the Hopline.

I live at 504 Oaklawn which is between Veterans and the Interstate near the cross street Toulouse. There is a Burger King on the corner where Oaklawn intersects Veterans near Dorignac's grocery. There will be parking available in my driveway, and my yard, but it is not advisable to park on the street. It's not illegal, but it's not safe either. It is better to park on Toulouse.
