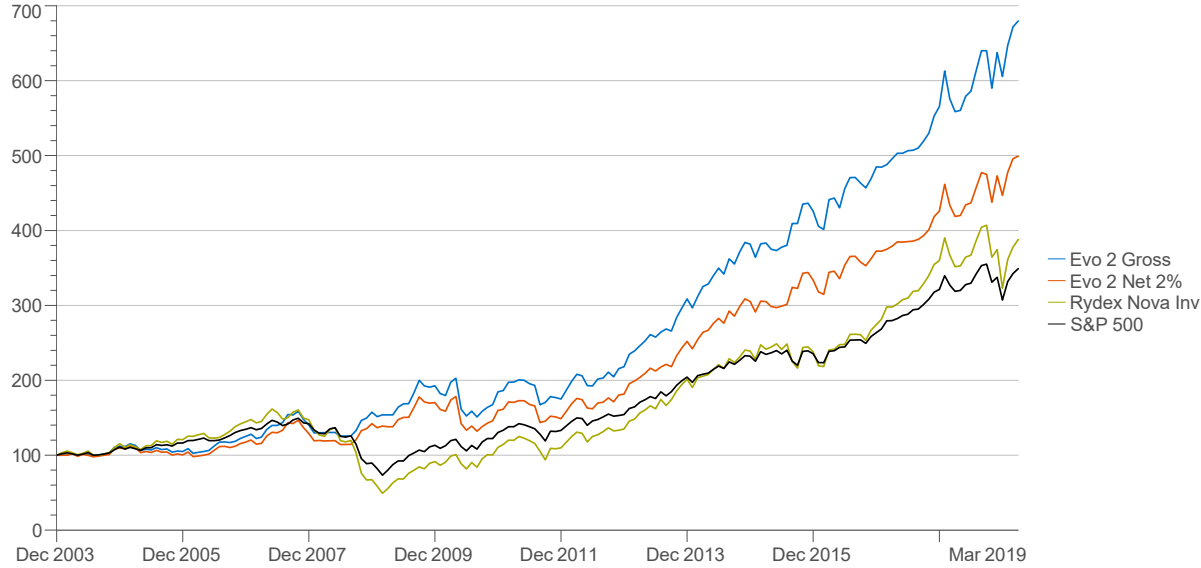

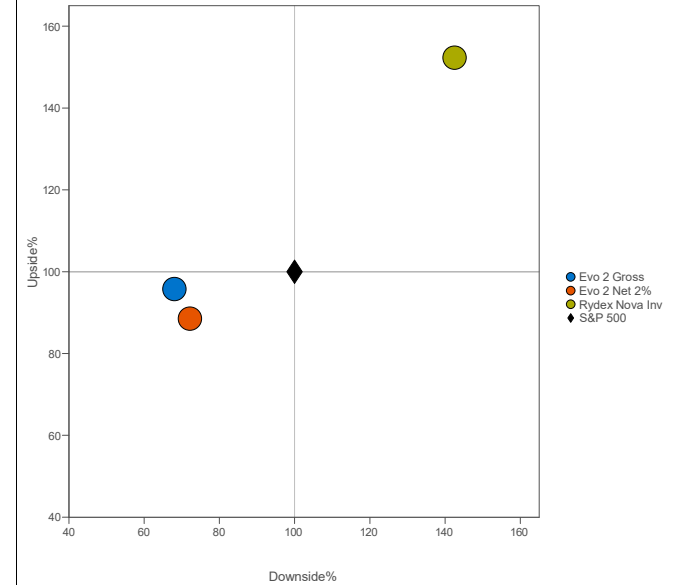

January 2004 - March 2019 (Single Computation)



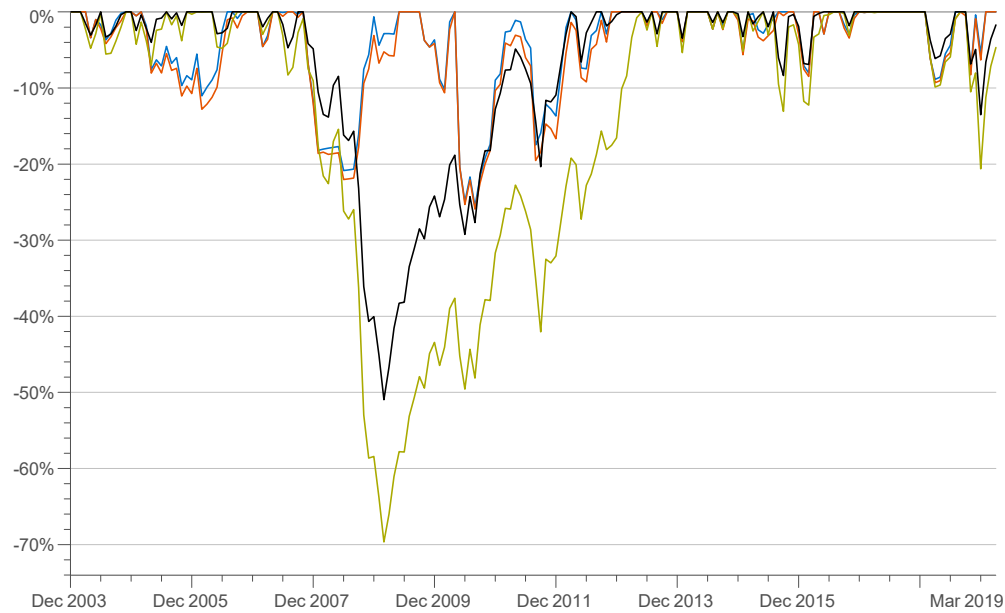

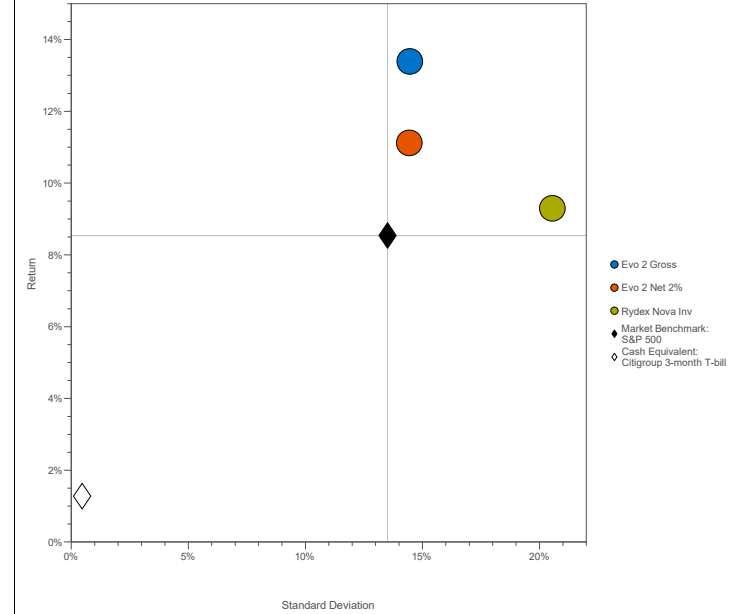

January 2004 - March 2019 (Single Computation)



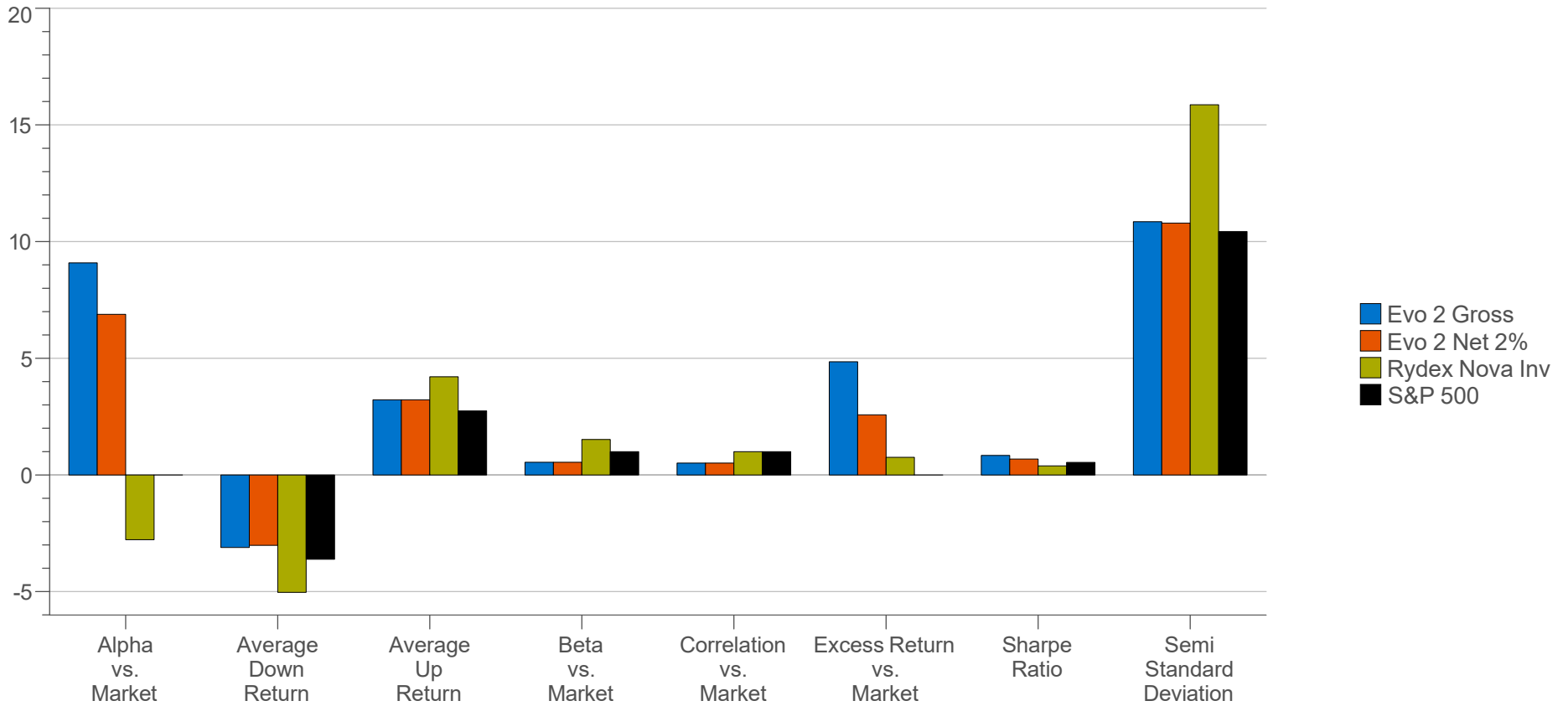
