PARKINSON HERO WALK

The Michigan Parkinson Foundation was successful in exceeding their fundraising goal this year with the annual Parkinson Hero Walk September 14th, located at Jimmy John's Field in Utica. Over \$258,000 was raised to help with programs and services that aid people who have the disease. Our own Sr. Vice Commandant Elect, Nate Jolliff, led the team that raised the most money out of all the teams present. In total, Team Jolliff brought in \$33,389 for the cause, which was in part through a donation from our Detachment.

Another detachment contribution to the event was our own color guard presenting the U.S. and Marine Corps flags during the singing of the National Anthem. The team looked sharp marching in step wearing their dress uniform while presenting the colors to get things kicked off.

A couple of Detachment members also joined Team Jolliff for the walk around the park and out on the trail. The total distance was three miles, and the weather conditions turned out to be perfect for such an activity. The sight of this had a great impact on those present as dozens of people happily marched together for the cause. It was a memorable day for all involved.

To top things off, Nate was later seen on television that night being interviewed about the event on the Fox 2 Detroit news program. He looked good and spoke very well about the importance of what had taken place that day. Marine Jolliff will make an excellent addition to the Detachment officers this coming year as he is a proven leader.
