The next day we went to another dog show and I was the "best boy" again, and also the "Best of Opposite Sex". (Mom said that meant a girlie was picked the best non-champion Scottie, but I was the handsomest boy again.) Of course! Was there any doubt? I also earned another point toward my championship. **That's 2 points down, 13 more to go-** and then I will be a champion Scottish Terrier. Heck, this dog show stuff isn't so tough!*

The Scotties that most closely meet the standard at each dog show will win ribbons, trophies and other awards, bragging rights, - and points toward their championship.

Shirley's Rescue Story

July 2011 was a bittersweet month. I had just lost my Scottie Agnes, but soon after received a call from Janet (our Rescue Chairman) about a Scottie girl that needed to be fostered by someone with a medical background (I'm a nurse). I said "yes!", but had to suppress my laughter when told that her name was *Shirley*! Somewhat in disbelief, I went to the Orange County Animal Services website and verified that animal #A209160 was, indeed, a Scottie named Shirley. I later learned that 5 year old Shirley was a police seizure, removed from a neglectful home along with her pit bull companion. Shirley's previous owners had been given an ultimatum- sign the dogs over to Animal Control, or go to jail! Fortunately for Shirley, they signed!



Shirley was initially taken to Orange County Animal Services who contacted STCTB. (Sadly, our club dealt with *many* rescues in 2011 due to the long downturn in the economy.) At the shelter Shirley was spayed; there was evidence she had at least one litter of puppies. Club member Leslie Condoleo picked Shirley up at the shelter and took her to veterinarian Dr. Liz McGrath, then to a groomer to clean up what little hair she had. Leslie told me that when she gave Shirley a flea treatment so many dead fleas came off that she needed a vacuum to get them off the floor! Shirley was also treated for hookworms and skin, eye and ear infections.

Several days later my sister Jane and I met Leslie at the midpoint between our homes (Orlando for Leslie, Clearwater for me) so I could take Shirley home to foster. I distinctly remember opening the door to Shirley's crate just as she coughed and sneezed, flinging mucus into the air!!! Shirley had come down with kennel cough that morning. I was shocked to see the condition she was in, which was much like the animals on the television show *Animal Cops*. She was *very* underweight. She had some hair on her face but little on her body. Her skin was covered in sores and hung in folds on her legs. She was very, very weak. I was surprised she had survived her spay surgery considering her poor condition. Leslie handed me Shirley's long list of medications and care directions, and I put her into my vehicle and took her home.

I carried Shirley into my house and have to admit I felt hesitant to touch her much because of the sores and her poor health. I was also worried that my Scottie boy, Tater, could pick up something from her. When I put her on a leash she was so weak she couldn't even make it to the house next door. But, Shirley quickly won us over as she wagged her tail and was so happy! In spite of past abuse and multiple health concerns she was still a happy go lucky Scottie who loved people!

Later I took Shirley and Tater to my vet, Greg Masters D.V.M. Tater needed preventives for kennel cough, and Shirley needed more treatment. He was as shocked as I at Shirley's condition. He gave me a prescription shampoo to use to bathe her 3 times a week and treated her for tapeworm and other problems.

Over time Shirley once again became a healthy and happy Scottie. Shirley has one of the most endearing personalities of any Scottie I have ever met. She also became an amazing athlete once her strength returned. She is very food motivated and we learned not to leave anything food-related on the dining room table unattended and to rearrange furniture so she could not use it as a springboard to the top of the table!!!! I have had three different people tell me that me if anything ever happened to me they would take Shirley in a heartbeat!

In November of 2011 I entered Shirley in the St. Petersburg Times (now the Tampa Bay Times) newspaper's Tampa Bay's Cutest Pet Contest. To my great pleasure, Shirley was named the grand prize winner that year.

There are no words to express the amount of love Shirley has to give. She has brought so much joy to our family, and she really is our gift from Heaven. I thank God every day for the gift of Shirley.

Oh, and one more thing. This dog was named correctly. As it turns out, Shirley really *is* a good name for a Scottie!

Make Homemade “Faux” Frosty Paws Treats for Your Scotties!

“Because dogs have trouble digesting the lactose in ice cream, it isn't a fun treat for dogs at all! However, we have several recipes we've tested that take all the fun of ice cream and make it into a safe treat you can make for or even share with your dog! One of our favorite Frosty Paws recipes (and the go-to recipe if you are trying to copy the commercial treat called Frosty Paws) is:

32 oz. plain yogurt
1 mashed banana

2 Tablespoons peanut butter
2 Tablespoons honey

1. Mix all these ingredients in your blender, then pour into ice cube trays or even a Kong toy to freeze and serve. Be sure the mold you freeze your treat into is either 1. large enough that your dog won't be able to swallow it whole when frozen solid. or 2. Shaped, like our bone ice cube trays, with slender sections so it can be crunched easier.

2. If you want to go all out...you can freeze these homemade frosty paws just like you would homemade ice cream. A salt-less automatic ice cream maker makes this as easy as using any other appliance in your home and the frosty paws will be ready to serve in 10 minutes.

For the ultimate treat, appropriate for dessert at a doggy birthday party, follow steps one and two, then take the mostly frozen dog ice cream product of number two and spread it about 1.5 inches thick on wax paper. Freeze for 5-10 minutes and then remove from freezer. Next, use a paw shaped cookie cutter to cut a paw shaped “frosty paws”, remove ice cream around edges, and return paw shapes to the freezer to freeze solid.

- Typical Ice Cream includes dairy (milk or cream), eggs, and sugar. When making frosty paws (a dog friendly alternative to ice cream) you'll want to substitute most of those items:
- Yogurt is a safe substitute for milk. The probiotics are great for your dog's digestive health, and this "good bacteria" breaks down most of the lactose by the time the yogurt is served.
- Sugar is not safe for dogs, but bananas, berries, apples, and other dog safe fruits can substitute in to make a sweet treat for your dog. A small amount of honey can sweeten the frosty paws while still being healthy for your dog- and is a great way to make the treat a favorite of pets AND kids! Keep in mind that your dog won't mind if the ice cream isn't sweet. Savory flavors can be added with low sodium chicken or beef broth, peanut butter, or even (if you are brave enough to prepare it!) liver.”
- Eggs- Dogs love eggs, and eggs are a fantastic nutritious treat. If you blend your Dog Ice Cream, toss a raw egg in the blender! (If your eggs are organic- include the shell for a boost of calcium that mimics what your pet would get by crunching raw bones in nature- although some dogs may object to the texture of this addition.)”

More STCTB Memories

In the 1980's Pete Clay asked me if I thought we could get a new Scotty Club started as the Miami Club was no longer active and STCA was encouraging formation of a new club in Florida.

Pete got in touch with Jackie Seelbach, who had been in STCA for many years. Although she lived in New Jersey she consented to be our mentor, and walked us through all the AKC applications and paper work so we were able to qualify for club status in record time!

Pete was our first President and I was Show Chairman, with much guidance from Pete. We held our first show in Lakeland at the Lakeland Civic Center in conjunction with the Combined Specialties Clubs of Florida. Our first Judge was Elaine Young from Washington state. If I remember right we had about 30 entries; everybody said that was great for our first show!

That was the beginning of our club. Each year we grew a little more and had some very famous breeders judge through out the years. I was Show Chairman for 10 years. I remember that the first year I was so nervous I stood at ring side during the whole show with my knees locked in place, ha! In spite of it, everything went off without a hitch and we were on our way.

Hope this helps some of you with a little back ground, more to follow next time.

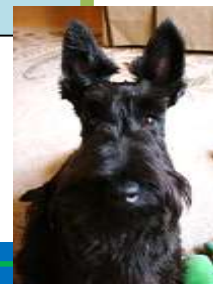

Health and Safety Features...

Beware of the Bufo Toad!

The toad pictured is known as the bufo toad (or cane toad, or *bufo marinus*). It was brought into Florida by the sugar barons from South America, where it has flourished with no known enemies other than the occasional unwitting snake who will be in trouble from its poison if it chooses to make a meal of it and, of course, man.

This toad can excrete enough poison to kill a small two-year old child. It definitely can and has killed many a dog who has mouthed and/or bitten into it. My vet tells me there is no known antidote – either your dog lives, or dies.

If your dog comes in contact with the poison (which is emitted as a foam and turns to clear liquid right away which is hard to see) immediately grab the hose and turn it into your dog's mouth from the side and rinse vigorously, using your hand to help wash off the poison. If you are lucky enough to have a pool there, dunk your dog's head in the pool and use your hand to rub all of the mouth area. Do this fast! Don't wait around thinking! Have a plan *in advance*.

Back in the 80's, it was early in the morning and one of the dogs kept barking and refused to go into the yard. The yard was not fenced and we lived on the waterfront. The grass had not been mowed in a while and was rather long. Looking out into the yard, we saw why the dog was barking frantically- there was a water moccasin over five feet long with a bufo toad in its mouth. Both creatures are poisonous and the poisons had joined together turning the toad a bright yellow. That was the only reason we saw them!

We were able to kill the snake, because his mouth was full and he was paralyzed from the poison from the toad. We then called the homeowners association telling them they had to cut the grass as it was dangerous. We hung the dead snake in the only tree in the yard to show the children. Later that day, the lawn crew cut everyone's grass but ours. When we questioned why we were told we had to remove the "voodoo" (the snake!) before the workers would enter our yard. That was a scary experience! We were lucky the snake got the bufo toad and not one of our dogs, or our dogs the toad! Check your yard before you let your dog out. It will probably be too late if your dog gets hold of a bufo toad.

We now have white metal fencing with 2 ½ inch spaced bars, which had to be approved by the homeowners association. We covered this fencing with a wire mesh which has very small holes, about ¼ inch. It comes in rolls and is approximately 3 feet tall. (You can find it at Lowes.) It was easily installed using the plastic hand-cuff type ties and we were very pleased with how nice it looked when we were finished. We then sunk bricks on their sides down in the ground at the bottom, to help keep the toads out and help with weed whacking. We also took fresh, unused, coffee grounds and spread them around the perimeter on the outside of the fencing at the suggestion of a neighbor who said they would help repel toads.



We have not had any toads since, except one the size of a baby finger fingernail which got through the fence at the gate and was easily disposed of- and that was *before* we tried the coffee grounds. Since laying down the coffee we have not had *any* toads in the fenced area of the yard- apparently, they don't like the smell of it. We have actually seen a toad go in the other direction when he got close to the coffee grounds. (We bought a large bag of "unused" coffee at Costco for this purpose- it was the cheapest.

Here's another tip. Do you have those little centipedes in your yard that are gray and curl into a ball? Put a wet string-type mop outside your door at night. In the morning, the mop will be filled with centipedes. Fill your laundry tub with the hottest water possible and/or boil a kettle and pour in. Put the mop into it and the centipedes die instantaneously and then go down the drain never to be seen again!

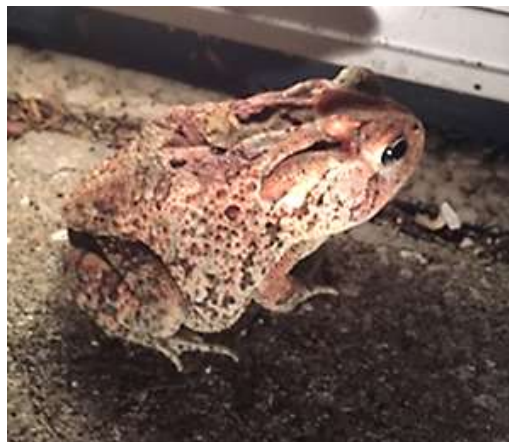

FOOD RECALL

NYLABONE PUPPY STARTER KIT RECALLED DUE TO POSSIBLE SALMONELLA HEALTH RISK

Nylabone Products of Neptune, NJ is recalling one lot of its 1.69 oz. package of the Puppy Starter Kit dog chews, because they have the potential to be contaminated with *Salmonella*. The recalled Puppy Starter Kit consists of one lot of dog chews that were distributed nationwide, to Canada, and through one domestic online mail order facility. The product comes in a 1.69oz. package marked with Lot #21935, UPC 0-18214-81291-3, located on the back of the package, and with an expiration date of 3/22/18 also stamped on the back of the package. The potential for contamination was noted after routine testing by the company revealed the presence of Salmonella in one lot of 1.69 oz. packages of the Puppy Starter Kit. No illnesses have been reported to date in connection with this problem.

Ainsley's Nylabone Event

I was enjoying reading [The Plaid Piper – May/June 2015 issue](#) when I came across a story by Susan Hamman, Sequim, WA, titled "Skyler's Nylabone Event" (page 13). It brought to mind a story about Nylabone and our five-year-old Scottie, Ainsley.

Over the years, I have had many dogs, many different breeds, from Dobermans, Pit Bulls, Golden Retrievers, mixed Rescues, Westies, Great Danes, to German Shepherds, to Scotties. I have found Scotties to have the most powerful jaws of *all* the dogs I've shared a roof with. Surprisingly, of all the aforementioned, and all the Nylabones I've purchased, none of them showed much interest in the Nylabones.

Recently, while shopping for something new and exciting for our Westies and Scottie, I came across a completely new-style Nylabone. It is shaped like a bone, but the one end unscrews and there are discs that slide off. You place "made in the USA" chewy discs in between the Nylabone discs and slide them back on the dowel and screw the end back on. The center discs had bristles like a tooth brush, up against the chewy discs. (The Nylabone pictured is a newer version that does not have the bristles.) This Nylabone is advertised as being able to clean your dogs' teeth. And because of the chewy discs, made from crunched up rawhide-looking material, they are very appealing to all of our dogs. They get very excited by them and fight over them like no other toy in their toy box. Or, I should say, they *did*. We have removed them permanently.



My husband, who I will now refer to as Eagle-Eye Chuck spotted something that looked like plastic on the floor. It was the bristles from one of the bones we had purchased for our dogs. Those bristles were a little over one-half inch long and were like needles or spikes. We were frantic! If one of those needle-like plastic pieces had been swallowed and pierced the stomach wall or intestines, which due to their sharpness was a distinct possibility, we were in trouble. We gathered up the remaining bones and examined them for missing pieces, counting the bristles and comparing. We were lucky! Nothing had been swallowed. *No* missing pieces. *No* more Nylabones- **ever!**

Breaking News! New Test Available for Leptospirosis

Janet Tomlinson shared a link to an important item on Leptospirosis, a potentially deadly and highly contagious bacterial infection that dogs can acquire through contact with contaminated soil or water. Many wild animals carry this bacteria and infect areas frequented by domestic animals. Leptospirosis can result in kidney and liver failure. Vaccinations are available to protect against Leptospirosis, but they are not 100% effective against the several strains of the disease.

The tests traditionally used to diagnose presence of Leptospirosis take several weeks to confirm the disease; during the waiting period for the results to be returned a dog could suffer severe health consequences or die.

A new diagnostic tool for Leptospirosis is now available called the [SNAP® Lepto Test](#). It can be performed right in your local veterinarian's office yielding results in approximately 10 minutes.

WHICH FRUITS CAN YOUR DOG SAFELY EAT? Top veterinarians answer the question

Dogs will eat pretty much anything that falls in front of them. For pet owners, that can be a scary reality.

Many people know the dangers of a dog snacking on dark chocolate, certain flowers or other common items that can be toxic. But what about fruits?

We reached out to a pair of experts from two of the nation's top veterinary medicine schools — Dr. Sherry Sanderson of the University of Georgia and Dr. Edward Cooper of the Ohio State University — asking them which common fruits were safe for a dog to eat and which ones they should avoid.

Sanderson was quick to point out that most commonly eaten fruits are fine for dogs to eat sparingly. "Where I have concerns is if pet owners want to give large quantities of these fruits to their dogs. If they get carried away with doing that, they could disrupt the nutrient balance of a complete and balanced commercial diet," she said.

Sanderson recommended that pet owners limit treat intake to less than 10 percent of the dog's daily caloric intake.

Both of the doctors agreed on which fruits were most dangerous for dogs — noting that grapes and raisins may cause

kidney failure — as well as the ones that were safe for consumption. Their major difference came in discussing lemons.

Both experts agreed that lemons were generally safe for dogs to eat but Sanderson said she would avoid giving them to a pet, "out of kindness." Meanwhile, Cooper joked that it "can be fun to watch their reaction to the bitterness."

Watermelon 	Safe for dogs to eat? Yes, except for the rind, which could cause intestinal obstruction <small>Dr. Edward Cooper, VMD</small>
