Approval of Minutes-

The Department has responded to 6 calls since the last Board meeting. As of August, they have responded to 50 calls. There has been about 5 responders per call. The trainings have been going well. Last night's training was at the Williams Fork Reservoir, working the pumps on the various apparatus and seeing what they can do and how to control them. EMS will be conducting a training doing a mapping course. This will help them find more rural addresses. They have ordered some new wildland equipment and reconditioning some tools. The new volunteers are working on various certifications.

Adoption of Cancer and Heart Trust Enrollment-

Marco DeAndrea motioned, and Aaron Bellefeuille seconded

Strategic Planning Process-

Aaron spent some time with the Department's volunteers to get some feedback concerning the strategic planning process. Some of the feedback was the following;

Need for infrastructure at the Parshall Station

Need for more volunteers, especially from the west side (Parshall) of the District (idea to achieve this is a volunteer information booth at the HSS Days Pancake Breakfast and hosting an Open House in Parshall and creating activities at that station to generate interest) Marco stated he could possible host some events to benefit the Parshall station and possible volunteer recruitment.

Need for ice rescue gear and updated wildland and firefighting gear

A side by side (4-person utility vehicle) would be a good addition to the department

Rob Firth asked Chief Tom if there was anyone designated to write grants for the Department. It is a time-consuming thing and he questioned if it might be worth hiring someone to do it. He will investigate what that cost would look like and who might be available to do it.
