HARVEST MOON CLASSIC OVERNIGHT RV PARKING

We ask all exhibitors to be patient with us as we are dealing with new Fairgrounds' on-site rules. We are the only event still permitted to park on the grounds so we are doing our best to make this work for all involved. **All RV parking** is through Gate 12 off Valley Avenue. Make the first right after passing the Watch & Wager Building and follow the signs. Do not proceed to your RV parking space without an escort. **\$50.00 per night for a 20' x 40' space.** If your vehicle is larger you must buy two spaces. **Reserved Box Van day parking \$35.00. Unreserved RV Overnight Parking** in large paved parking lot is \$55.00 per night. All reservations after the deadline will be considered non-reserved and the nightly rate of \$55.00 will apply. **Electrical hookups** not guaranteed. If available in your area you will be charged **\$40.00 for electrical.** Del Valle does not make a profit on RV parking; we are simply passing along to you what we are charged. Trailers and tow units will be required to be unhitched. Tagalong vehicles will be parked in a special area. **All vehicles** must have a working fire extinguisher, be self-contained and no discharge of gray water permitted. No electrical cords permitted across paths or roadways. Persons who break open locked boxes or otherwise damage property in order to find electricity will be held responsible for damage and may be asked to leave. No running of generators after 11:00 P.M. or before 5:00 A.M. Those wishing to park together must send reservations in together, however there is no guarantee that we can accommodate all requests. **All parking** is at your own risk. Neither the Alameda Co. Fair Assn. or Harvest Moon Classic assumes any responsibility for fire, theft, and/or loss of vehicles or their contents. Ring 10, 12, outdoors just west of Exhibition Building B

Rings 13, 14, 15, 16, Hall of Commerce Building C

Rings 20, 21, outdoors on the Knoll

Enter Gate 12 off Valley Avenue, turn right at first opportunity onto Roadway #6, left onto Roadway #8 and right into the Main Parking lot. There is an unloading loop to the building doors from 6 a.m. to 6 p.m.

Rings 22, 23, in The Trees

Rings 24, 25, 26, in The Rose Garden

Rings 36, 50, 52, 53, in Bernal Greens

Best unloading for these rings is through the **Main Gate off Pleasanton Avenue** between 6 and 7:15 a.m. All exhibitors may drive onto the grounds, unload near your ring and then back out the Main Gate, left onto Pleasanton Avenue and entry into parking lot across the street is on the right at the east end. All vehicles must be off the grounds by 7:30 a.m. After 7:15 a.m. you will trolley your dogs and equipment in through the Main Gate. Only after all judging has concluded in these rings will you be able to drive onto the grounds to load up.

Ring 17, Agriculture Building P

Ring 18, Minerals & Gems Building O

Ring 19, Building R

Rings 41, 42, 43, 44, 45, 46, 47, in The North Forty

Exhibitors should **enter through Gate 12 off Valley Avenue**, proceed straight ahead, heading east on Roadway #12, pass Agility rings on left, and make a right at the end and go through the tunnel. All exhibitors may drive onto the grounds, unload near your ring between 6 and 7:15 a.m. All vehicles must be off the grounds by 7:30 a.m. After 7:15 a.m. an unloading loop will operate all day.

The Clubs and their Superintendent caution all persons entering the show site and show grounds against all hazards which may exist, including, but not limited to: Condition of the site/grounds, parking/loading/unloading areas, entrances, floors and stairways, elevators and escalators, floor coverings, walkways, tenting/canopies, electrical appliances, cords and fittings, exercise pens, and the presence of animals. All persons should take into consideration this is a sporting event and dress, act and exercise caution appropriate for the activity involved. All persons entering the show, the grounds, site and show areas for whatever purpose do so entirely at their own risk. By virtue of entering the show, the entrant has indicated their acceptance of the terms listed in the premium list and assumes all risks involved.

A judge requesting the use of a ramp must give notice to the show superintendent/show secretary prior to judging. AKC approval is not required.

The entire entry in a breed is to be examined in the same manner (ground, table, or ramp).

At the discretion of the judge, the following breeds may be judged on the ground or on a ramp through all levels of competition including Group and Best in Show judging: Lagotti Romagnoli, American Water Spaniels, Clumber Spaniels, English Springer Spaniels, Field Spaniels, Welsh Springer Spaniels, Cirneci dell'Etna, American Staffordshire Terriers, Irish Terriers, Kerry Blue Terriers, Soft Coated Wheaten Terriers, Staffordshire Bull Terriers, Finnish Spitz, Keeshonden, Entlebucher Mountain Dogs, Finnish Lapphunds, Norwegian Buhunds, Polish Lowland Sheepdogs, Spanish Water Dogs, and Norrbottenspets (Misc.).

At the discretion of the judge through all levels of competition including Group and Best in Show judging, the following breeds may be judged on the ground, a ramp, or on a table: Boykin Spaniels and Whippets.

The following breeds must be judged on a ramp through all levels of conformation competition: Sussex Spaniels, Basset Hounds, Bulldogs, Chinese Shar-Pei and Chow Chows. This extends to all conformation competition at AKC conformation dog shows and any AKC event where a conformation title may be earned. This policy includes Group, BIS, Junior Showmanship, the 4-6 Month Beginner Puppy Competition, the AKC National Owner-Handled Series (NOHS), and all other special attractions that offer Group and BIS competitions.

Ramps can be used in emergency situations to judge any breed. In an emergency situation, where use of a ramp is not indicated in the premium list, an exhibitor has the option of withdrawing their entry and receiving a refund.

For the judging of juniors the ramp may be used at the discretion of the judge for the ramp optional breeds.

NOTICE

Juniors who win a third Novice Class with competition present, after the closing of entries for a show, ARE REQUIRED TO TRANSFER their entry from the Novice Class to the Open Class BY NOTIFYING the Superintendent or Show Secretary at least one half hour prior to the scheduled start of Junior Showmanship judging at the show.

JUNIORS WITH A DOG ALSO ENTERED IN ANOTHER CLASS OFFERED AT THIS SHOW WHO SUBSTITUTE A DOG NOT ENTERED IN THIS SHOW MUST REMIT THE DIFFERENCE BETWEEN JUNIOR ONLY AND JUNIOR AS AN ADDITIONAL CLASS ENTRY FEE. JUNIORS WHO HAVE ENTERED JUNIOR SHOWMANSHIP ONLY WHO THEN SUBSTITUTE ANOTHER DOG WILL NOT BE CHARGED A FURTHER FEE.

THERE IS TO BE ABSOLUTELY NO TAPE PUT ON THE FLOOR OF ANY BUILDINGS. THERE WILL BE A FINE OF \$250.00 ASSESSED TO ANYONE FOUND DOING SO.

Rings 1, 2, 3, Exhibition Building B. Exhibitors in these rings should use the Young California Building A for grooming and set-ups. Grooming is permitted around the outside perimeter of this building. Crates are permitted indoors in the designated areas while your breed is being judged. Building available for set-up NO EARLIER than 2:00 p.m. on Thursday October 18th.

Rings 4, 5, 6, 7, Young California Building A. Grooming and set-ups are permitted in this building in designated areas. Dogs may be left overnight at owner's risk. Please label each crate with dog's name, your name and cell number. No exercise pens permitted indoors, except in the event of rain. Exception: Cocker pens are permitted as long as there is plastic underneath and they are kept scrupulously clean. In consideration of others please stack crates and don't set-up "livingrooms." Building is locked from 10 p.m. to 6 a.m. Building available for set-up NO EARLIER than 2:00 p.m. Thursday October 18th

Rings 10, 12. Exhibitors in these rings should use the Young California Building A for grooming and set-ups.

Rings 13, 14, 15, 16, Hall of Commerce Building C. This building is for obedience and rally exhibitors only. No set-ups before 2:00 p.m. Thursday October 18th.

Rings 20, 21, 22, 23, 24, 25, 26, 36. Indoor grooming is available in the designated areas of the Young California Building. There are bathtubs placed around the grounds for your use. No set-ups before 2:00 p.m. Thursday October 18th

Ring 17, Agriculture Building P. Access to this building allowed after 2 p.m. Friday, October 19. This building is in use on Saturday only for exhibitors of Cavaliers. All dogs and equipment must be removed from this building after the Cavalier Specialty concludes.

Ring 18, Minerals & Gems Building O. Access to this building allowed after 2 p.m. Thursday, October 18. This building is for exhibitors of Poodles only. No exercise pens in building except in the event of rain. Building will be locked between 10 p.m. and 6 a.m.

Ring 19, Building R. Access to this building after 2:00 p.m. Thursday October 18. This building is for English Springer Spaniels & Pug exhibitors only. No exercise pens in building except in the event of rain. Building will be locked between 10 pm and 6 a.m.

Rings 41, 42, 43, 44, 45, 46, 47, 50, 52, 53. Indoor grooming is available in the designated areas of the Young California Building. There are bathtubs placed around the grounds for your use. No set-ups before 2:00 p.m. Thursday October 18th.

Dog Washing on the Fairgrounds

Please note important information!

The 1996 Clean Water Act is now being enforced at the Alameda County Fairgrounds. All gray water (which includes soapy water from washing dogs) must be discharged into sanitary sewer systems only and not dumped onto the ground or into storm drains. A hefty fine can be leveled against offenders. Del Valle will be placing Dog Bathtubs around the grounds for your convenience. Please check the Fairgrounds map in the Judging Program for designated dog washing locations. We will do our best to make it easy for all of you.

8th Annual Harvest Moon Junior Classic ~ Sponsored by Harvest Moon Classic "Best Junior in Cluster"

All Junior Showmanship class winners from the Friday, Saturday and Sunday all-breed dog shows are eligible to compete for the Grand Best Junior of the weekend. Class winners are eligible to show throughout the weekend but may opt out of Sunday's regular competition in order to rest for the preliminary finals. Grand Best Junior will be announced in the group ring prior to group judging and the preliminary finals will be comprised of a 3 person judging panel - Top 20 Style. These judges will be announced at the Preliminary Finals ring. On Sunday, regular junior showmanship class judging will be in the morning while finals preliminary judging will take place in the afternoon.

Finals Judging:

Stage 1 - Preliminary: All Junior Showmanship class winners from the Friday, Saturday and Sunday all breed dog shows will enter the designated preliminary ring in the afternoon on Sunday. Once checked in, the class will be cut into sections to keep the ring manageable. It will not matter who is in each section, as the scores will be competing all participants against one another. There will be three judges in this ring - while one judge is working, the other two will be observing. Each judge will have responsibility for an aspect of presentation - for example, one will perform individual examination, another will move each handler individually etc. Each judge will have a scorecard and will be scoring each handler based on preset objectives. Once judging is complete, the scores will be tallied. All handlers re-enter the ring and the Top 6 Finalists are announced. These juniors will come to the group rings for the presentation of Grand Best Junior.

Stage 2 - Announcement of Winner: The Top 6 Finalists enter the group ring. The announcer will explain the process by which the finalists were chosen, and the 3 judges will allow each junior to do a quick showcase of their skills. Grand Best Junior will then be announced.

The winner of Grand Best Junior will receive a 32 GB iPod Touch as well as a plane ticket to either the 2018 AKC National Championship or 2019 Westminster Kennel Club dog show.

AKC National Owner-Handled Series - All Three Days

The AKC National Owner-Handled Series is a non-titling competition for dogs that are exhibited by their owners that are not professional handlers. Exhibitors must declare their dog is Owner-Handled eligible at the time of entry on the entry form. Dogs entered in the Amateur-Owner-Handler class will automatically be marked as eligible to compete in the NOHS. Eligible dogs will be identified by an asterisk in the judge's book, steward's book & the catalog. **Dogs must be handled throughout the breed level competition for the regular show by an eligible owner. Professional handlers*, household members and current assistants** to professional handlers may not exhibit the dog in any NOHS competition during the entire show.** Owner-Handled Best of Breed will be selected from the dogs that are eligible to compete in the Best of Breed competition including Winners Dog, Winners Bitch and winners of the non-regular classes.

- If the Best of Breed/Variety winner is Owner-Handled competition eligible, it will automatically be Owner-Handled Best of Breed/Variety and be eligible to compete in both the regular as well as the Owner-Handled group.
- If the Best of Breed/Variety winner is not eligible for Owner-Handled competition and the Best of Opposite Sex to Best of Breed/Variety is eligible, the Best of Opposite Sex to Best of Breed/Variety will compete against the eligible exhibits of the other sex to determine Owner-Handled Best of Breed/Variety.
- If neither the Best of Breed nor the Best of Opposite Sex to Best of Breed/Variety are Owner-Handled competition eligible and Select Dog & Select Bitch are both eligible, the judge is to choose Best Owner-Handled exhibit from the Selects and eligible Winners Dog or Winners Bitch.
- If one of the Selects is eligible, excuse all Champions and non-regular class winners of the same sex and then choose Best Owner-Handled exhibit from the remaining dogs of the opposite sex including the eligible Winners.
- If Best of Breed, Best of Opposite Sex to Best of Breed, Select Dog & Select Bitch are not eligible, the judge may choose any eligible dog remaining in the ring including Winners Dog or Winners Bitch as Owner-Handled Best of Breed/Variety.
- If the Best of Winners is eligible, the other Winner is ineligible since it was defeated.
- No class dogs other than the Winners Dog & Winners Bitch are eligible to return to the ring.

The breed will not be represented in the Owner-Handled Group if there is no eligible dog competing in the Best of Breed or in Best of Winners competition. *Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years. **A current assistant is defined as anyone employed by a professional handler on a full-time basis, or assisting a professional handler at the show or any time during the cluster/weekend. Current assistants that are eligible to compete in Junior Showmanship (meet age & amateur status requirements) may participate in NOHS.

AKC Sanctioned 4 & Under 6 Months Puppy Competition All Three Days

One combined class will be offered for breeds and varieties of dogs that are (4) four months & under (6) six months and divided into Groups as described in Chapter 3, Section 1 of the *Rules Applying to Dog Shows* and the Miscellaneous Class breeds as listed in Chapter 3, Section 23. **There will be a selection of Best 4 & Under 6 Months Puppy in each Breed/Variety**, each Best 4 & Under 6 Months Puppy in Breed/Variety winner will then compete in their respective group for First through Fourth Placements. The Miscellaneous Class Competition will be judged same as above followed by a Miscellaneous 4 & Under 6 Months Puppy Group Competition. The Foundation Stock Service Class Competition will be judged same as above followed by a FSS 4 & Under 6 Months Puppy Group Competition. All First Place Group Winners will be eligible to compete in Best 4 & Under 6 Months Puppy in Show. An AKC registration number or AKC litter number will be required for entries of an AKC recognized breed or Miscellaneous breed. FSS number or FSS registered litter number will be required for FSS entries. A foreign born dog may enter this class if they are registered in the country of origin. Dogs are required to be vaccinated (including rabies) in accordance with their veterinarian's protocol in order to avoid inadvertent transmission of illness by/to puppies not yet fully immunized. Dogs that are owned or co-owned by a professional handler may compete in this class, but must be handled by a non-professional handler. *Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years. Dogs may not be exhibited by current assistants or household members of a professional handler. A current assistant is defined as anyone employed by a professional handler on a full-time basis, or, assisting a professional handler at the show or any show during the cluster/weekend. AKC Rules in Dealing with Misconduct* will be applicable to any person and dog entered at this competition. All applicable rules found in *Rules Applying to Dog Shows* will govern the conduct of this competition unless these regulations state otherwise. Exhibitors should plan on opening the mouth of their puppy for the judges. Breed standard disqualifications such as color, height, weight or dentition shall not be a point of consideration in the judging process for this 4 & Under 6 Months Puppy in Show Competition.

IN THE 4-6 MONTH PUPPY COMPETITION, MAY BE ON THE GROUNDS.**

Harvest Moon Classic ~ Awards of Merit ~ Each Day

In appreciation of these major entries, the Harvest Moon Classic offers **AWARDS OF MERIT**, deserved recognition of the quality dogs who are in serious contention for the top awards. It is entirely the judge's decision whether to give all of the available Awards of Merit, only some, or none. Awards of Merit are selected from dogs and bitches in Best of Breed Competition, **other** than the Best of Breed/Variety and Best of Opposite Sex. Select Dog or Select Bitch winners. There will be a special Single Streamer Black & White Rosette for each Award of Merit recipient.

The number of awards that may be made is determined by the size of the entry:

Awards of Merit will be offered in those breeds with a Specials entry in Best of Breed Competition as outlined below:

- 1 Award of Merit - 10 to 14 Specials
- 2 Awards of Merit - 15 to 19 Specials
- 3 Awards of Merit - 20 or more Specials

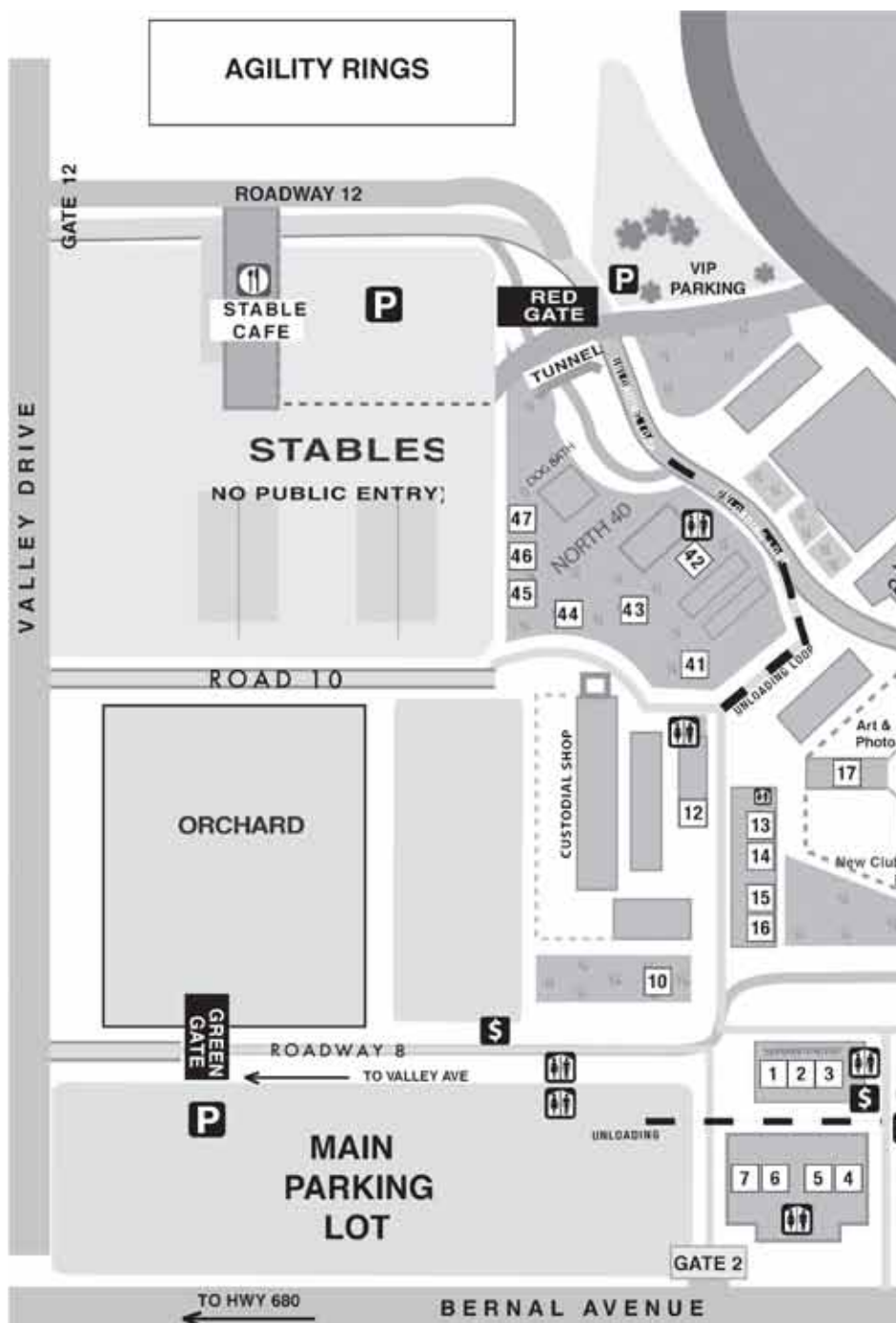

The Pee Wee Special Attraction is a pre-Junior Showmanship class. The Pee Wee class is geared toward children 5 to under 9 years of age at all shows offering Pee Wee. Each Pee Wee unit consists of the child, his/her parent/guardian/responsible adult, and the dog. Only one Pee Wee unit is in the ring at a time. This is not a competitive class, but rather a fun, learning experience for the child and the adult.

- A dog must be at least four months of age to enter the Pee Wee class.
- Bitches in season will not be allowed to participate.
- All dogs entered must have the proper lead and collar.
- A responsible adult must be present with the child both inside and outside the ring. The adult is to maintain control of the dog outside of the ring.
- All AKC fully recognized and Miscellaneous Class breeds are allowed to enter, including dogs with a PAL listing.
- In addition to an entry, a release must be signed by the child's parent or legal guardian. Release forms will be available at the show.

The safety of both the dogs and Juniors inside and outside the ring is a primary concern. Outside of the ring, the dog is to be controlled by the adult accompanying the child. An additional lead, provided by the Club, will be at the Judge's table. At the Judge's discretion based upon the size of the child and the dog, for safety purposes the adult may be asked to attach a second lead to the dog so both child and adult will walk the dog together. Although the word "judge" will be used, this is designed to be a learning and mentoring experience—no Junior will be "judged" but rather will be mentored with the age appropriate amount of information to help prepare them for what they will be expected to know about AKC regular Junior Showmanship once they reach 9 years of age. The children will be mentored one child, their adult, and dog in the ring at a time. The Judge should explain the process of showing the dog to the Junior and the responsible adult in the ring including breed specific presentation. Depending on the size of the dog and the child, the adult may be asked to lift a table breed on or off the table, or the Club may mandate that the adult should do it regardless. Neither the youngster nor the adult should be asked to show the bite. Each child will receive a participation ribbon to commemorate the experience and a stuffed dog donated by Janet Allen.
