WHEREAS, the Annual Budget for the Township of Jackson Fire District No. 2 for the fiscal year beginning January 1, 2014 and ending December 31, 2014 has been presented before the Board of Commissioners of the Fire District No. 2 at its open public meeting of December 9, 2013; and

WHEREAS, the budget as introduced is in compliance with the Property Tax Levy Cap Law (N.J.S.A. 40A:4-45.44 et. seq.); and,



WHEREAS, in calculating the amount to be raised by taxation, the Fire District No. 2 has taken into account the assessed valuation of taxable property in the Fire District No. 2,

NOW, THEREFORE BE IT RESOLVED, by the Board of Commissioners of the Township of Jackson Fire District No. 2, at an open public meeting held on December 9, 2013 that the Annual Budget, including appended Supplemental Schedules, of the Township of Jackson Fire District No. 2 for the fiscal year beginning January 1, 2014 and ending December 31, 2014 is hereby approved; and

BE IT FURTHER RESOLVED, that the anticipated revenues as reflected in the Annual Budget are of sufficient amount to meet all proposed expenditures/expenses and all covenants, terms and provisions as stipulated in the said Fire District No. 2's outstanding debt obligations, capital lease arrangements, service contracts, and other pledged agreements; and

FISCAL YEAR: From January 1, 2014 to December 31, 2014

The proposed 2014 Budget is increasing by \$77,072. The majority of the increase is from contractual pay increases and hospitalization premiums. The other large increase is for maintenance and repairs to the aging apparatus fleet.

2. Complete a brief statement describing the impact the proposed Annual Budget will have on the Amount to be Raised by Taxation to support the district budget and on the Restricted and Unreserved Fund Balance(s). Explain increases or decreases in the tax rate and utilization of fund balances. **If unreserved fund balance is reduced by more than 10%, explain the projected impact on the following year's budget.**

The amount to be raised by taxation in 2014 will increase by \$29,572. This small increase will increase the fire tax rate in 2014 by \$.001 per \$100 of assessed valuation. The Board is utilizing \$39,500 of operating surplus to offset part of the budget increase. This will leave a surplus of \$159,042.

3. Include a statement explaining how the District is complying with the Property Tax Levy Cap. The statement must explain reasons for exceeding the Levy Cap and identify the appropriations that caused the district to exceed the Levy Cap, and how they are being addressed by a referendum.

The 2014 proposed budget is in compliance with the Property Tax Levy Cap.

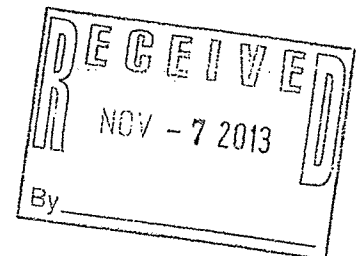


