The City of Cynthiana Board of Commissioners met in special session on May 5, 2015 at 5:00 P.M. in the Commissioner's Room at City Hall. Present were Mayor Smith, Commissioners Grayson, Mattmiller, Slade and Attorney Lair.

Mayor Smith reported the purpose of the meeting.

CALL TO ORDER

Commissioner Slade made a motion to change classification of Blake Bishop from part-time Telecommunicator to full-time Telecommunicator effective 5/5/2015. Salary commensurate with position. Commissioner Grayson seconded. Vote: Commissioner Slade: yes; Commissioner Grayson: yes; Commissioner Mattmiller: yes; Mayor Smith: yes. Motion carried.

CHANGE B BISHOP

Commissioner Slade made a motion to change classification of Wilbur Gross from part-time Telecommunicator to full-time Telecommunicator effective 5/5/2015. Salary commensurate with position. Commissioner Mattmiller seconded. Vote: Commissioner Slade: yes; Commissioner Mattmiller: yes; Commissioner Grayson: yes; Mayor Smith: yes. Motion carried.

Mayor Smith explained the process of filling the vacancy of Commissioner Walter Tapp. Once the Commission makes an appointment that Commissioner will only be in office until the November 25, 2015 general election. Mayor Smith stated that several people have expressed interest in the position. Mayor asked each Commissioner to report the names of the people that had contacted them expressing interest.
