

ARMY ALMANAC MAY 2017 Milestones in Army History

- **225 Years Ago** 08 May 1792, Congress passes the Militia Act "to establish a uniform militia throughout the United States". The legislation also calls for compulsory universal service for all free, white male citizens between the ages of eighteen and forty-five.
- **205 Years Ago** 14 May 1812, Congress establishes the Ordnance department (birthday of the Ordnance Corps).
- **190 Years Ago** 26 May 1827, Author and poet **Edgar Allan Poe** enlists in the Army under the name of **Edgar Allan Perry**.

- **175 Years Ago** 17 May 1842, Two companies of the 7th Infantry engage a band of Indians near Fort Wachahoota and Clay's Landing at the Suwanee River in Florida in the final combat actions of the Second Seminole War.
- **140 Years Ago** 05 May 1877, **Crazy Horse**, leader of the Oglala Lakota Sioux, and approximately 1,000 of his followers surrender at the Red Cloud Agency, Fort Robinson, Nebraska.
- **120 Years Ago** 31 May 1897, The Army discharges fifty-three Indian scouts of troop L, 7th Cavalry, bringing an official end to the Indian Scouts.
- 100 Years Ago 26 May 1917, Major General John J. "Black Jack" Pershing is appointed Commander-In-Chief of the American Expeditionary Forces and prepares to depart the United States to establish his headquarters in France.
- **75 Years Ago** 214 May 1942, **President Franklin D. Roosevelt** signs legislation creating the Women's Army Auxiliary Corps.
- **70 Years Ago** 24 May 1947, The U.S. Army Military Group Greece is established to assist Greek forces in their fight against Communist insurgents.
- **65 Years Ago** 07 May 10 June 1952, U.S. forces, including elements of the 187th Airborne Regimental Combat Team, clash with Communist prisoners of war held at Koje-do Island, South Korea.
- **48 Years Ago** 11 May 1969, Battle of Dong Ap Bai (**Hamburger Hill**) begins.
- **48 Years Ago** 20 May 1969, Battle of Dong Ap Bai (<u>Hamburger Hill</u>) ends.

Days are long at the United States Military Academy. Reveille awakens the cadets at 0600 (6 a.m.) and lights are put out by Taps at 2200 (10 p.m.). For the new cadets - the Plebes - the day starts even earlier as they perform several chores for upperclassmen and their barracks mates as a whole. At 0600, the Hellcats rend the dark gray of the morning with Reveille and other drum and bugle tunes. Within minutes the cadets, many only half awake, have formed into company formations. At times, the Hellcats provide a drum and bugle cadence for the Corps as it marches to the Mess Hall for breakfast.

The Hellcats are a group of the West Point Band, which is the oldest in the Army.¹ It is composed of a baker's dozen buglers and drummers. Since the West Point Band started in 1778 with a fifer and a drummer, the Hellcats are a direct descendent of those two men. Given their lineage, the Hellcats are often called upon to perform at Corps of Cadet parades and reviews, tattoos and other ceremonies.

But to "Old Grads" the Hellcats will always bring back memories of mornings at the Academy with its wake-up call of drums and bugles.

The Lord has given each of us a wake-up call. Obviously we have the Bible, which is an explicit call to live a life pleasing to God. But, even if one has neither read the Bible nor been schooled in its teachings, God has made himself known. Every sunrise, sunset, rain shower, storm, type of flora and fauna provides evidence of His existence. The love between individuals or, especially, between a parent and child is manifest proof of God's existence. Our consciences speak to us not only of His Being, but also of what our proper conduct should be.

As Paul wrote, "The wrath of God is being revealed from heaven against all the godlessness and wickedness of people, who suppress the truth by wickedness, since what may be known about God is plain to them, because God has made it plain to them. For since the creation of the world God's invisible qualities—his eternal power and divine nature—have been clearly seen, being understood from what has been made, so without that people are excuse." 1:18-20) (Romans

Anthem Veterans Memorial, Arizona



Once a year at 11:11 am the sun shines perfectly on this Memorial. At precisely11:11 a.m. each Veterans Day (Nov. 11), the sun's rays pass through the ellipses of the five Armed Services pillars to form a perfect solar spotlight over a mosaic of The Great Seal of the United States.

The <u>Anthem Veterans Memorial</u>, located in Anthem, Arizona, is a monument dedicated to honoring the service and sacrifice of the United States armed forces. The pillar provides a place of honor and reflection for veterans, their

family and friends, and those who want to show their respects to those service men and women who have and continue to courageously serve the Unite States

The memorial was designed by Anthem resident Renee Palmer-Jones. The five marble pillars represent the five branches of the United States military. They are staggered in size (from 17 feet to 6 feet) and ordered in accordance with the Department of Defense prescribed precedence, ranging from the United States Army, the United States Marine Corps, the United States Navy, the United States Coast Guard.

Additionally, the brick pavers within the Circle of Honor are inscribed with the names of over 750 U.S. servicemen and women, symbolizing the 'support' for the Armed Forces. The pavers are red, the pillars are white, and the sky is blue to represent America's flag. The circle represents an unbreakable border. Anthem resident and chief engineer, Jim Martin was responsible for aligning the memorial accurately with the sun.

This statue currently stands outside the Iraqi palace, now home to the 4th Infantry Division. It will eventually be shipped home and put in the memorial museum in Fort Hood, Texas.

The statue was created by an Iraqi artist named Kalat, who for years was forced by Saddam Hussein to make the many hundreds of bronze busts of Saddam that dotted Baghdad. Kalat was so grateful for the American's liberation of his country; he melted 3 of the heads of the fallen Saddam and made the statue as a memorial to the American Soldiers and their fallen warriors. Kalat worked on this memorial night and day for several months.

To the left of the kneeling soldier is a small Iraqi girl giving the soldier comfort as he mourns the loss of his comrade in arms.

New VA website will feature up-todate wait times, patients' reviews

The VA will unveil a new website this month that will help veterans make better choices about their health care, Secretary of the VA David Shulkin told MOAA members Tuesday, April 4. "You will simply type in where you live or where you want to get care and ... automatically what will pop up is where you can get that care within the VA system and what the wait time will be," Shulkin said. The VA secretary was the keynote speaker at a briefing to prepare members of MOAA's board of directors, chapter leaders from across the country, and headquarters staff members before the association's annual Storming the Hill event, which took place Wednesday, April 5. The new site, which Shulkin said will launch in the next two weeks, also will allow veterans to rate their care at VA facilities. Allowing patients to see what their peers think about a VA facility will help improve transparency, he said.

"We all know that there are some really, really good VAs and some that need a lot of work," Shulkin said. "You're going to be able to see which ones they are based on what your fellow veterans say." The new tools are part of the secretary's 10-point plan to modernize VA care. While the department posts wait times on its website now, Shulkin said they're often buried in hard-to-read spreadsheets. "I've spent a lot of years training in data and statistical analysis, and I can tell you that I can't

understand the data on the VA website," he said. "[The information] is all there, it's all accurate - but I don't see how it helps anyone." VA officials have been holding focus groups with veterans on the new website. The goal, Shulkin said, is to make sure the information they're trying to provide on the new site is easy to understand and helpful.

Shulkin, who spent most of his career in the private sector, said VA employees must start viewing veterans as their customers. Though he disagrees with the push to privatize VA care, he said creating some competition outside the system could be a good thing. If veterans are unhappy with the care they receive from the VA, he said, they'll "vote with their feet" and leave the system. That could be devastating to his department, which is why he said it's important to make sure veterans are treated well and have the tools they need to make important decisions about their health.

The House and Senate passed legislation to extend the VA's Choice program. Choice, which was set to expire in August, allows some veterans to seek care outside the VA. Now that the program has been successfully extended, Shulkin said he'll turn his attention toward rewriting the Choice rules. His hope is that a better version of the program becomes a permanent part of the VA's budget, he said. part of that plan, Shulkin said he would remove the "40-mile, 30-day rule" that currently restricts veterans from going outside the VA for care if they are within 40 miles of a facility or face wait times under 30 days. "I hope to be able to give more veterans a choice," Shulkin said.

President signs resolution authorizing National Desert Storm War Memorial

Veterans of Operations Desert Shield and Desert Storm will soon have their own memorial on the National Mall in Washington, D.C., thanks to legislation signed today by the president.

President Trump signed Senate Joint Resolution 1, "A joint resolution approving the location of a memorial to commemorate and honor the members of the Armed Forces who served on active duty in support of Operation Desert Storm or Operation Desert Shield." The resolution was sponsored by Indiana Sen. Joe Donnelly and Arkansas Sen. John Boozman and designates the location of the memorial on the National Mall.

"I appreciate the commitment of my colleagues in the House of Representatives to swiftly approve this resolution so our Gulf War Veterans are appropriately honored for their service and sacrifice in our nation's capital," Sen. Boozman said.

"This resolution is the final step in Congress to create a memorial in our nation's capital that loved ones and future generations can visit to honor the men and women who fought and died for our country in the First Gulf War," Sen. Donnelly added.

The National Desert Storm War Memorial will honor those Veterans who served in the Gulf War in 1990 and 1991. Now that legislation to create the memorial has been approved, the memorial's sponsors will begin the process of fundraising and working with the National Capital Planning Commission to select a location on the National Mall and a final design. Funds for the construction of the memorial will be raised privately by the National Desert Storm War Memorial Association.


Chapter LX has members deployed overseas in support of the War on Terror. Some of these men are still
