

24/01948/TCONR Stonegate, Naunton, GL54 3AF Field Maple (T1) located right hand side of the house. Reduce tree by 2 metres to clear building. Holly Tree (T2) located at the left hand side of the driveway. Reduce height of tree by 3 metres and raise crown by 1 metre. Weeping Beech (T3) located at the back of the property, by the treehouse. Crown raise section on the bank by 1 metre.

As this is tree maintenance, rather than felling, NPC's policy of not objecting applies unless Councillors would like to comment.

#### 7) FROG team and equipment

Jonathan Noble has resigned from the FROG team due to ill health. The FROG equipment has been problematic and is now quite old. Subscriptions to the FROG flood reporting service have fallen. Councillors to decide on any action.

#### 8) Steps to the boules pitch

A resident has noted that the steps could be dangerous for some residents and would be much safer if a handrail was installed. Councillors to consider whether to fund this request. Funds could be allocated from the infrastructure budget. Measurements will be needed and a decision on materials – galvanised steel or wrought iron. Appx cost of railing expected to be around £200 with additional labour costs.
