

RED DOOR AND LEMON TREE FILM GALA RANDOM TRIP DRAW TERMS AND CONDITIONS

Ariadne's Red Chair Films Inc. (the "Sponsor") is hosting a random trip draw (the "Draw") at the film Gala (the "Gala") for their upcoming feature-length motion picture "Red Door and Lemon Tree" on September 8, 2017. This Draw is open to all Gala attendees who are residents of Ontario and there's no fee to enter.

These Terms and Conditions are governed by the Sponsor. The act of entering the Draw constitutes acceptance of these Terms and Conditions.

PARTICIPATION

1. PERIOD

The Draw takes place on Friday, September 8, 2017 at the Gala event.

2. ENTRY AND ELIGIBILITY

There is no entry fee associated with this Draw. To enter the Draw, an individual (the "Entrant") must submit the used stub from his/her ticket to the Gala on the day of the event to be put into the Draw. One entry per Entrant. Entrants may submit their stubs with designated Sponsor employees or Gala volunteers, at the entrance of Parkview Manor (the "Venue"), or as noted during special announcements during the night of the Gala, prior to 9:00pm. The Draw is open to all Gala ticket-holders who attend the Gala. Individuals under the age of eighteen (18) are not eligible to be entered into the Draw. Employees of the Sponsor, or any of its subsidiaries or contractors, or family members or household members of an employee of the Sponsor, its subsidiaries or contractors, or anyone else connected with the Draw may not enter the Draw. Entrants into the Draw shall be deemed to have accepted these Terms and Conditions.

3. PRIZE

One (1) Entrant's ticket will be randomly selected in a draw on the night of the Gala and declared the Draw winner (the "Winner"). The Winner will be awarded a prize (the "Prize"). There is one (1) Prize available. The Prize is a 7-night stay in a Porto Sea View room with access to pool at PORTO ELOUNDA GOLF & SPA RESORT (CRETE, GREECE), for two persons, including breakfast (excluding flights), for reservations made in the following periods: May 1 to May 26, 2018 and September 15 to October 30, 2018. The Prize is valued at approximately € 2,100 (\$3,200 CAD). The Winner agrees to accept the Prize as offered and as-is.

4. DRAW

The Draw will take place on-stage at the Venue, during the Gala, between 9:00pm and 10:00pm. During the Draw, designated attendants will randomly select and announce the winning ticket number, on-stage. The Winner must present the ticket with the corresponding winning ticket number to the on-stage attendants conducting the draw. If the Winner does not claim the Prize by approaching the stage within a few moments of the announcement of the winning ticket number, as reasonably determined by the on-stage attendants, the Winner will be re-drawn. This process will continue until the Winner is determined and the Prize is claimed.

To be declared a winner, the selected winner must:

(a) First correctly answer, unaided, a time-limited, mathematical skill-testing question;

(b) Sign a release form, in a form acceptable to the Sponsor; and

(c) Consent to their name, city and likeness to be used in any promotional materials, social media, advertising, news releases or photography as deemed appropriate by the Sponsor for promotion.

5. ODDS

The odds of winning the Draw will depend on the number of Entrants that enter the Draw. Every ticket to the Draw has an equal chance of winning.

GENERAL TERMS AND CONDITIONS

The decision of the Sponsor is final on all matters of fact, interpretation, eligibility, procedure and fulfillment in all matters related to this Draw and without appeal.

The Sponsor reserves the right to require proof of age and jurisdiction of residence prior to awarding any prize.

The Sponsor may, at its sole discretion, alter, amend, suspend, or cancel this Draw or amend the Draw procedures at any time, subject to applicable law, or prohibit any person from entering any Draw that it believes to be abusing the rules.
