THE MEETING WAS OPENED WITH THE FLAG SALUTE.

At 7:00 PM Supervisor Tompkins opened the meeting.

PUBLIC COMMENTS ON AGENDA ITEMS

None

Supervisor Tompkins advised that this was a special meeting to approve the Highway 284. Councilman Welsh added that this is important work to do and time sensitive for proper weather. Councilman McMorris said there was much back up paperwork and emails and he hopes everyone was able to research the material. Supervisor Tompkins asked if in the future it can be done earlier, as to take advantage of the lower escalation fees which will save the taxpayer money. Councilman Frazier pointed out that the fuel prices were lower today than at the beginning of the season. Supervisor Tompkins noted that she found in her research that prices had increased even though the fuel pump prices are lower.

Councilman McMorris noted that there was much speculation in some of the quotes and asked if the bills could increase in price, dependent on what is found in the subsurface. Superintendent Wisseman said historically that has not happened before however, he will be contacted if a situation like that occurs in which he would then contact the Town Board. Supervisor Tompkins then read the price per ton for the past few months.

Supervisor Tompkins asked how much of the work will be done in house with Town employees. Mr. Wisseman replied that they are doing all the drainage and tree work however, they will not be doing the blacktopping, reclamation or road flagging. They will be using their truck for water for the roller to save money but cannot provide the truck for the reclamation due to size. Supervisor Tompkins then asked if he was mirroring what was there or changing it and if so, what will the changes be. Mr. Wisseman said he will be inputting a heavier base. She further inquired when the last time the road was done to which 1999 was thought to be the correct year, although Mr. Wisseman could not find any literature on the topic. Supervisor Tompkins inquired if there will be any changes in the structure of the road. Mr. Wisseman said they will be correcting the drainage by adding more and additionally throughout any other wet spots and adding Portland and binder to create a longer lasting road that is more impervious to water.

RESOLUTION #17-72 APPROVING HIGHWAY DEPARTMENT PURSUANT TO HIGHWAY LAW §284
