## Minutes of Last Meeting

## IHC General Meeting International Harvester Collectors Club Iowa Chapter #5 Avoca, IA November 8, 2017

- Call to Order- 12:15 p.m. President Brian Holdeman Chapter 5 General Meeting to order. Directors present were Arland Jolly, Craig Wessels, Rod Richardson, Aaron Wade, Calvin Mennenga, Gene Putz, Paul Schaffer and Treasurer Ray Cook. Absent was Wayne Schoel.
- Secretary's Report Craig Wessels read the minutes from the September 3, 2017 meeting. Motion to approve the minutes by Bobbie Hammer, 2<sup>nd</sup> by Robert Macomber. Motion carried.
- Treasurer's Report Ray Cook gave the Treasurer's Report. As of October 31, 2017 there was a beginning balance of \$147,188.82, income of \$861.22, expenses were \$1,714.30 for an ending balance of \$146,335.74. There is still some income and expenses from the show book and a few toy sales to come in yet. This will be Ray's last treasurer's report, he is retiring at the end of the year. Calvin Mennenga will take over the treasurer's position on January 1, 2018. Calvin will remain on the board through the end of his term, then if he wishes, he can continue to be the Treasurer as a non-voting advisor to the board. Motion to accept the report by Bob Gihring, 2<sup>nd</sup> by Tom Johnson. Motion carried.
- RPRU 2017–Brian Holdeman We are very close to wrapping things up from the show. Pam has the show books at the printer and will be mailed out in about the next month. The pedal tractors are all sold out. There are about 50 semis left. We will sell 42 of them to a toy dealer for \$80 a piece and the club will keep 8 for the chapter table to sell. Denny is still needing ideas for the belt buckle give away, please help him with some ideas. With the profits from the RPRU we are looking in to increasing our scholarship and 4-H grant pro-

- (Con't) grams. The directors came up with a plan to present to the membership today for approval. We would like to give out \$15,000 a year, half of the \$7,500 will go to Scholarship program and the other half \$7,500 will go to the 4-H grant progam. We would like to plan on doing this for 6 years. That will be \$90,000 total for the 6 years. That will still leave the club with over \$50,000 to use for club needs and to use for future shows. This plan will be up to a yearly review to make changes as needed. Currently we do \$3,000 in Scholarships and give \$6,000 to the 4-H, so this plan is a nice improvement. A motion to proceed with the plan was made by Joe Neville, 2<sup>nd</sup> by Pam Olson. Motion carried.
- Newsletter and Website Report Pam Olson-Deadline for the next newsletter will be December
  15<sup>th</sup>. I only have 60 members signed up for email only. We would like to increase this to help with cost of printing and mailing of the newsletter. The cost of a newsletter and postage is \$1.67 per issue.
- National Board Joe Neville The ballots for national board directors were out in the last issue of Harvester Highlights. Please take some time to fill them out and send them in. Another thing we have been working on is updating the guidelines for a RPRU.
- Merchandise Report Bobbie Hammer We only have one show to report on, it was the state show, we sold \$1,225.
- Membership Report Karen Reiter We currently have 657 members. If your phone number or address has changed or are a snow bird please let me know.
- Scholarships Bob Gihring Since we have more money available now I will make up a new set of guidelines for our application. I will have them for our January meeting.


# Minutes (con't)
