LEGISLATION

SB 1109: Opioid Addiction & Education Act. This passed unanimously in Committee by both sides. This provides label and substances.

Our support is needed for the following:

SB 976: Saving our Communities from Violent Felons Act. This would close a loophole on Prop 57 and prevent the early release of felons and sex offenders and define "serious" violent felonies.

AB 1290: Competitiveness & Innovation Act. This would reduce the middle class tax rate, eliminate the franchise tax on small business and double the \$7,000 homeowner's property tax exemption.

SB 902: Background checks for sober living homes.

DISTRICT ATTORNEY TONY **RACKAUCKAS**

At the Dana Point Civic Association, Rackauckas reported closing many sober living homes that were not licensed by the state. His office has a new hotline for reporting any Sober Living Home concerns: (714) 647- 3228.

ASSEMBLY MEMBER BILL BROUGH

AB 1900: California Economic Incentive Package. Encourages and retains business. AB 2349: Veteran Assistance Act. This would exempt military retirement pay from

state income tax to keep their excellent skills in California.

AB 2231: Lawsuit Abuse. This would reform the California Voting Rights Act to help taxpayers.


CITY OF DANA POINT

Dana Point, along with many Orange County cities voted to support the resolution against the State SB: "Sanctuary City" law.

FAILED BILLS

SB 827: Scott Wiener (D), California Housing Bill. This bill fortunately failed as it mandated four and five story housing structures one half a mile from rail stops.

Also hoping SB 320 fails: This would require CSU and US campuses to provide the abortion pill free of charge.

Memorial Day, originally called Decoration Day, is a holiday dedicated to the memory of those who died in service to the United States.

- It was first announced on May 6, 1868, by General John Logan in his General Order 11, and was observed on May 30, 1868, when flowers were placed on the graves of Confederate and Union war dead at Arlington Cemetery.
- Many in the South refused to recognize the day, preferring to honor their dead on a separate day. This changed after World War I when the holiday was changed from honoring just Civil War dead to all soldiers who died fighting in American wars.

March winds bring April showers April showers bring May flowers So...what do May flowers bring?


