We also passed out MN Operation Lifesaver information, Remember: ANYTIME IS TRAIN TIME AT RAIL-ROAD CROSSINGS.



What IS Operation: Lifesaver?

In 1972, a Union Pacific employee working with the support of many Idaho Communities to establish a State wide Operation Lifesaver program. The 1st year accidents dropped by 39%. Encouraged by the results, the UP helped Nebraska start a state wide program in 1973. That year the number of collisions was reduced by 46%. I am happy to report, as of today, we have seen an 82% Decline since 1972 with a high of roughly 12,000 annual incidents to approximately 2,200 incidents in 2019. Most of what we talk about are things that people have just started taking for granted and don't always think

about or pay attention when crossing tracks. Operation Lifesaver program is also in other countries helping to reduce their accidents.

We talk about the 3 E's which are: Education, Engineering and Enforcement at Railroad crossings.

Education – Operation Lifesaver educates the public of all ages about grade crossing and pedestrian safety. We hope people will share what they learn so there will be less accidents/incidents at railroad crossings.


Engineering- is responsible for keeping the crossings as safe as possible and making improvements where needed.

Enforcement – Operation Lifesaver encourages an active enforcement effort. If existing laws governing crossings are not enforced, they will be ignored or broken. Collisions will continue to happen.

We talk to people of all ages, using age-appropriate information and materials. You are never too young to help spread the word. When I first started, I talked to some preschool children and when their bus driver got to the crossing, they were so quiet she put the bus in park and put the break on and ask the children what was going on. They told her about what we talked about and by the end of the next week I was talking to her and other school bus drivers. We have presentation for everyone from drivers like you, truck drivers, bus drivers, student

drivers, emergency responders, police officers and pedestrians. Something for everyone no matter what you drive or how old you are.

Young children like the preschoolers and elementary age



absorb the knowledge and repeat it to others, parents, grandparents, etc. I am still greeted at local stores, events and schools as 'The Train Man'. Some young children, some teenagers, adults and often parents that tell, about their child and the impact this program made on them and their families.

In America, a person or vehicle is hit by a train roughly every 3 hours and that is a reality we are committed to change, by talking to people about what they do at Railroad crossing, around tracks and railroad property. Trespassing

> is covered in our talks to remind us that tracks and bridges are railroad private property. 2/3 of collisions happen in daylight hours and $\frac{1}{4}$ (25%) of collisions is where the car runs into the train. Half (50%) of collisions happen at crossings with automatic warning devices. Most fatalities occur within 25 miles of the driver's home with the train moving 35 mph or less, the driver being 30 vears old on average. Trains have the right-of- way. When you been crossing the tracks and have not seen a train in a while; you still need to stop; as train schedules change all the

time. You can not be replaced. Always take the safe way. At a crossing that is blocked for a long time, never should pedestrians cross between the train cars, because train cars can move without warning. You can reschedule a doctor's appointment or explain why you are late to school. You cannot be replaced. Placing items on tracks can become a maiming or deadly reaction for individuals, derailment can also result from this action. "Look- Listen- Live" is also a slogan to remind all of us to be aware around railroad tracks and crossings. It can take over a mile (5280 feet) to stop for a train to stop traveling at 55 MPH.

We used to be known as Operation Lifesaver presenter's a few years back we were changed to: Operation Lifesaver Authorized Volunteer. (OLAV). We have volunteers in every walk of life, from railroad workers to police officers, minister and teachers. If you would like to help, make your community safer, along with more information about Operation Lifesaver, just contact your state's Coordinator. 


Cody Walker, above, poses for a picture for a fan at the 2021 Fuel Fest in Los Angeles on Father's Day weekend.














Stay Cool this Summer

As you begin to plan your summer activities and vacations, don't forget to plan for extreme heat. Extreme heat events are expected to become more common, severe and longer-lasting in the United States. Extreme heat events are a long period of time (2-3 days) of high heat and humidity with temperatures above 90 degrees.

Heat can be a killer. The combination of hot weather and high humidity can cause heat-related illnesses to set in, which may lead to death. Those who are at highest risk of heat-related illness in-



clude people aged 65 and older, children younger than two, people who are pregnant, and people with chronic diseases or mental illness. During extreme heat events, make sure to connect with family members, friends and neighbors and remind them to take protective actions. The National Weather Service recommends the following tips:

• Hydrate. Whether you feel thirsty or not, drink plenty of water to avoid becoming dehydrated, especially when you're working or exercising

outside.

• Educate yourself. Keep up with the latest temperature and heat index forecasts and current readings (take actions to stay cool and safe when the temperatures hit 85 degrees or the heat index hits 90 degrees). Know the warning signs of a heat illness, and how you can stay cool.

• Act quickly when a heat illness is suspected. Seek medical attention immediately for any of these warning signs: cramping, rapid pulse, heavy sweating, hot red skin, dizziness, confusion, nausea, vomiting.

• Take it easy. Anyone working or exercising outdoors should avoid overexertion, especially between the hours of 11 am and 6 pm. Take hourly breaks in the shade or in air conditioning.

The best time to prepare for an extreme heat event is now. The Environmental Protection Agency (EPA) and Centers for Disease Control and Prevention (CDC) suggest checking your household fans, air conditioners and other cooling equipment each spring to make sure they are in good working order. They recommend taking other mitigation steps in your home, like planting trees in strategic locations, installing a cool roof and using cool paving materials in your driveway.

Stay informed! Look up the location of your nearest cooling center, which are buildings (e.g., libraries, shelters, community buildings) with air conditioning that are designated as a safe location during extreme heat events. Check the weather before heading outside and sign up for heat alerts. In fact, you can download the FEMA App to receive real-time alerts from the National Weather Service. Visit Ready.gov for more tips and to learn more about extreme heat.


