## VI. Other Business

- 1. Amendment Proposal for allowing Board to create and revise rules within bylaws
  - i) First vote failed due to lack of returned ballots (34 received)
    - a. Ballots not received are counted as a "No" vote
    - b. Need 41 "Yes" to approve
  - ii) Current ballots due June 1<sup>st</sup>
    - a. Legal action taken to enforce bylaws while voting
    - b. Legal action taken to commence another vote
    - c. If approved, mortgage companies then need to approve
      - i. Michigan Law states no response from companies within 90 days is counted as an approval, per our lawyer

## iii) Feedback

- a. Rec Vehicles are different than company vehicles
- b. Concerns from residents that our community has lost the "neighborly" feel
- c. Concerns that people will no longer want to live in our sub if we cannot have rec vehicles given proximity to lakes and campgrounds
- d. Some homeowners bought in here during previous "unofficial" bylaws that allowed rec vehicles and company vehicles
  - i. Would not have purchased with "official" bylaws

- e. Some members would like to start enforcing other bylaws, such as garage doors being open, all vehicles and garbage cans in garages
  - i. Would prefer to remain neighborly and address gross negligent issues only to allow flexibility
- f. If members go door to door to encourage voting, please do not provide your opinions on the vote or bias other members opinions. Only encourage members to submit ballot to allow for official voting process versus default due to lack of response.
- g. Board does not plan to conduct a third vote without a petition
