OEA-R Delegate Briefing, December 2, 2016

- Scott DiMauro, OEA Vice President, gave the STRS screening results. The recommended candidates are Carol Corruthers (active), Robert Stein and Rita Walters. (retired)
- STRS Deputy Executive Director of Member Benefits, Gary Russel spoke: an experience study, asset mix and health care. He added there are no new funds being put into health care, and right now there is about 3 billion dollars in the fund.
- Becky Higgins, OEA President, talked about the election results not being what we had hoped for and that public education is in for a battle. She also talked about the intergenerational mentoring program and that we should always remember to say thank you to people for all the work they do.
- Tim Myers said that OEA has 123,466 members which is 2,967 more than last year. He also said that OEA will be frugal over the next 2 year budget. There will be an additional \$1.7 million dollars because of a \$16 dues increase. Tim announced that the OEA building is paid off, but they are looking at some building repairs.
- Sheryl Mathis, OEA Executive Director, stressed the need to build relationships with members. She said public education and unions are under a full frontal attack from the new president elect. Fair share, fair wage laws and the possibility of shutting

- down the US Department of Education are three issues to be concerned about.
- The FCPE report from Pam Smith showed that 32 people donated \$1,665. Good job!
- Jeff Rhodes, NEA Director from Ohio, talked to members on the Hill about ESEA, the Supreme Court nomination, institutional racism, the election and concerns with charter schools, vouchers, and taking money from educational funding.
- Wil Vickery gave the Legislative report.
- OEA-R Board of Directors member Carol Kinsey discussed the Louisville strike. Members are back in the classroom, but have not settled.
- New Business Items passed. The first NB was OEA-R demands that OEA go back to paper balloting for elections. The second NB was there should be a report given at each OEA-R assembly on how much money is made from baskets that are raffled and how is this money being spent.
- Tamika Moss, candidate for OEA Board of Directors At Large, spoke then OEA-R voted to endorse her. (37 for and 1 against)
- The final credentials report showed that there were 41 delegates and 3 quests.

The OEA-R Spring Conference is being sponsored by NWOEA and NCOEA. It will be at the Kingwood Center in Mansfield on Wednesday, April 26, 2017. The cost is \$25 and reservations must be made by April 12.

For Retired Seats on the STRS Board

OEA REPRESENTATIVE ASSEMBLY, December 3, 2016

- Opening ceremonies occurred, preliminary credentials report was 330 delegates.
- Becky Higgins started the FCPE kick-off. Last assembly FCPE collected \$28,873.
- There were no recommendations from Constitution and By-Laws.
- Tamika Moss was elected by acclamation.
- Kory Swope, president of the Louisville Education Association (LEA) reported: it was a 16 day strike, are back in the classroom, but have not settled. They have not been back to the table since June. The concern from LEA is not money, but that all voices are heard and the members are given RESPECT. Ten members of LEA have been suspended and were not allowed to go back into the classroom. LEA has a partnership with parents, government officials and other unions. Almost \$6,000 was donated by the delegates.
- President, Becky Higgins said there were fewer OEA members who volunteered for the election and she stressed the need for open communication.

- •Scott DiMauro led the discussion of the Legislative Report. The report was adopted as amended. Priorities for 2017 include equity in educational funding, testing, OTES, school report cards and meeting the needs of the whole child.
- Financial report given by Tim Myers: concern with membership, a \$1.2 million in increased expenses, and the average teacher salary went down.
- Julie Garcia and Ella Jordan Isaacs shared information from the Social Justice Task Force.
- There were two NB items. Both NB items PASSED. NB 1 stated that OEA vehemently opposes the appointment of Betsy DeVos as US Secretary of Education and calls on Sherrod Brown and Rob Portman to vote against her confirmation. The cost of this NB item is \$1,300. NB 2 stated that beginning with the 132nd Ohio Legislature, OEA shall establish an online Legislative Scorecard for all members of the General Assembly that outlines votes in support of education.

Women's March on Washington Jan. 21, 2017

On Jan. 20 I boarded a bus at 11:15PM bound for the Women's March in Washington. I did not go because my candidate did not win the Presidency. At the march, I saw no violence, no arrests, and no illegal actions. What I did see were women, men and children of every age and color supporting and caring for each other. What I did see and feel was an overwhelming sense of unity, friendship, helpfulness, and purpose. Every marcher there had their own reasons for marching. I need to stand.

Jeanette Johnson of Capital won and seemed very pleased!!! Strike at Lousiville The teachers went back to work since many needed their benefits. A big thank you to all who donated. The delegates to the OEA Rep Assembly donated approximately \$6,000.00.
