### Fees and business practices

### **The Process ~**

1. **Homeopathic Intake:** A complete history including chief complaint and personal characteristics. If something additional comes up, I may contact you through phone or email. Based on this, I analyze your information and determine a remedy. This typically takes between 2-10 days. I mail your first **remedy**, which is billed separately based upon potency and type.

2. **Follow up appointment** is scheduled 4-6 weeks later, after taking your **remedy**, to assess the action of the remedy. This appointment lasts 30 - 60 minutes. If the appointment continues beyond 60 minutes, it is considered an “**extended visit**” and will be charged accordingly. Additional follow-ups will be scheduled depending on how you are doing, typically every 4-6 weeks until your chief complaint is 70-100% improved.

*Recommend: give homeopathy 6 months to see a clear change. During that period of time, you might have 3-5 follow up visits. This is an average. Many people experience a complete reversal of symptoms very rapidly. Others take longer. Most appreciate the supportive relationship with me as a health care provider and go on to utilize homeopathy as an important line of defense for acute concerns as well as continued constitutional healing.*

3. **Acutes Care:** Acute care is the treatment of brief, suddenly occurring conditions such as **colds, flu, injuries, bites, toxic exposures**, etc. Homeopathic treatment of these conditions serves to strengthen the constitution, exercise the immune system, and ultimately increase your health in a powerful way. Limiting your use of suppressive treatment during these times is central to improving the trajectory of your overall health.

**Acute consults** are conducted during daytime hours (8am-5pm) unless initiated, or requested, by your practitioner. Messages or emails received on Friday will not be answered until Monday unless **after hours care** (see #5) is requested. Remedies are billed separately.
