

Financial performance for CV continues to look good and get stronger as the Board remains diligent in its fiscal responsibility negotiating strong contracts for services but not at the risk of value erosion. Year to date through the first quarter, annual collections stand at 92% which is on par at this time of year. The performance indicators for the operating budget (pictured above) reflect good to steady state spend against budget showing a marginal surplus through March 31, 2016 although there is slight increase in G&A expenses due to a higher number of delinquent accounts the Board are seeking to recover.

On a different note, the Board has to address some unexpected repairs and new requirements imposed by the City of Houston in order to ensure the pool is ready for the summer. To address these requirements the Board will have to spend approximately \$20K requiring us to pull funds from the reserve.

Additionally, if you have kept up with the news lately, Mayor Turner is proposing to stop trash pickup reimbursements to those communities that rely on private trash pickup as an incentive. This reimbursement represents a significant revenue generation to our annual budget. The Board will keep a close watch on how this develops and will plan accordingly.
