DCR Update

- Statewide Fire Danger Low
- Some changes to staffing an additional position was added
- Cutting projects for fire roads continues
- Towers will be up dependent upon weather as well as more towers up West Brookfield & Oxford

- Training Committee
 - No meeting
 - Recap of recruit training costs were estimated around 12k came in just over 6k

- Radio Committee

- Annual maintenance on the "Orange" system is being conducted. System is over 10 years old. Some problems have been found.
- Additional fireground channels are being put together. They are trying to get this together once for programming.
- Backup link being moved to Oxford tower
- FCAM Update

- Homeland Security

 - \$125k allocated for tech equipment/structural collapse class

- Tech Rescue Committee

- Approved 1 additional hour of training due to need to ensure everyone gets to actively participated in the evolution and time to clean up
- Approved one additional training in April, to be a joint training with the dive team
- Design of helmet decals has been submitted to Chief Bemis for committee to review
- Accountability "Tags" are going to be given to team leaders to distribute (Dive and TRT)
- Mock activation this past weekend with dive to test paging etc. Anyone who did not get page is getting identified and corrected in system
- Meeting with dive team postponed and will be rescheduled

State Mobilization

- A review of the past Statewide Mobilizations was reviewed. Chief Wilson brought up our concern of being deployed two consecutive days in a row. Committee was in conflict on how to handle. Chief Wilson recommends if D-7 assets are requested to return to the same incident the following day, after a long duration of the first day, we inform the requesting District we are unavailable. While we made the response to Leominster happen, it was a stress on our people and equipment.
- Chief Wilson also suggested we send our Comm Team with any activation to work with our people not necessarily work with the area we are going to.

- EMS Committee
 - NFPA stretcher There are new changes to the accepted stretcher systems allowed in ambulances as of July 1, 2015. The Chair of the committee has reached out to the State and at this time there is no commitment from state.

Old Business:

- Standardized MAY DAY Policy (Chief Zinther created a DRAFT under review) All agreed in principle to the District-wide approach. Some questions revolved around some acronyms being used. The consensus was to follow DFS acronyms. Chief Coleman to follow up and make the adjustments.
