

## SHOW RULES & REGULATIONS

Agreement made between Specialized Events, Inc. Hereafter named Rubber Stamp and Scrapbook Expo, & the Exhibitor

### **Exhibitor Space & Display** 1)

- All booths must reflect a high level of professional and artistic integrity.
- Unoccupied exhibitor booths not occupied within 2 hours of opening on the first day of show, exhibitor will forfeit booth, which may be filed b) by standby exhibitor, however the original exhibitor will still be liable for full payment.
- Only one paid exhibitor per booth, exhibitor shall not sell, assign or sublet any booth space allotted to them without prior written consent of Rubber Stamp and Scrapbook Expo. Any violation of this provision shall be deemed a default of this agreement.
- Displays are to be clean and neat. All back stock and storage containers must be out of public view. All table coverings must be fire retardant. Exhibitors must bring materials to cover their displays after set-up and at night. Do not staple covers to tables
- No display materials shall be suspended or hung from walls or columns without prior approval of Rubber Stamp and Scrapbook Expo.
- Electric Use shall not exceed 500 watts and exhibitor agrees to not use electrical bulbs with wattage greater than that specified on the lamp/fixture. Exhibitors shall provide own electrical outlet strip & 25 foot extension cord. All lights, cords & other electrical equipment must comply with the National Electric Code Underwriters Laboratories, Inc. Standards.
- Booth merchandise must be Paper Craft related materials unless approved by Rubber Stamp and Scrapbook Expo.
- Exhibitors may use their own tables and or racks in the booth space if they stay within their paid booth space and do not intrude on neighboring booths.

### **Exhibitor & Merchandise** 2)

- Exhibitor must comply with all Federal Trade Commission rules. No deep discount sales or going out of business signs may be displayed.
- All Exhibitors shall have the appropriate federal & state tax permits and licenses & are responsible for collecting and remitting sales tax to the appropriate governmental authorities. Any exhibitor who fails to display the required sales tax licenses shall not be allowed to participate in the show.
- All Exhibitors shall have merchandise retail priced and may sell as a wholesale provider to qualified buyers. k)
- No alcohol beverages or smoking is allowed in the exhibition area.
- Exhibitors shall be responsible for any damage to tables, chairs, floor or wall located within exhibitor space. m)
- No exhibitors will be allowed to dismantle booth space prior to show closing time and must be dismantled within 5 hours after show closing.
- Exhibitors shall not hold Rubber Stamp and Scrapbook Expo responsible for any lost, stolen or damaged merchandise: nor any damage or injury to any exhibitor or person representing or employed by same. Any thefts must be reported to show management immediately upon discovery.
- Exhibit space must be open and occupied by exhibitor at all times during show hours.
- Liability insurance may be purchased by Exhibitors against all risks implicit or explicit in its participation in the show, at exhibitor expense.
- All Exhibitors are required to wear appropriate identification ie. badges/tags provided by Rubber Stamp and Scrapbook Expo. r)
- Exhibitors may use their own tables, racks and or display cases in assigned booth space that do not intrude or impede neighboring booths.

#### Rubber Stamp and Scrapbook Expo 3)

- Shall provide night security utilizing either security guards, locks, chains and / or alarms. Day security provided by security guards and / or management.
- Exhibitor agrees to not hold Rubber Stamp and Scrapbook Expo for the safety or loss of merchandise & display materials whether during b) show hours and after show hours.
- Shall make sure that the access to display at exposition is limited to those persons, firms, corporations & other entities that have contracted and paid for exhibitor booth space inside the venue. No other individuals, firms, corporations & other entities will be permitted to demonstrate products, solicit orders or distribute or advertise on the floor of the exhibition facility.
- Reserves the right to make changes in show location & floor plan.
- Rubber Stamp and Scrapbook Expo or its parent company Specialized Events, Inc. (SEI) reserves the right to co-locate any other shows e) owned and operated by SEI with the Rubber Stamp and Scrapbook Expo sharing the same venue. Retains the right to remove exhibitor not complying with the Terms of this Agreement, without refunding offending exhibitor's monies.
- f) Reserves the right at its sole discretion to settle all disputes between exhibitors & also between exhibitor & customer concerning returns, exchanges and refunds.
- Will promptly refund to exhibitors all sums paid for exhibition space should Rubber Stamp and Scrapbook Expo fail to perform show as agreed. This refund shall be accepted by the exhibitor in full settlement of all loss or damage suffered by exhibitors do to such failure to hold this exhibition.
- Rubber Stamp and Scrapbook Expo dba/Specialized Events makes no guarantee of sales results, participation or show attendance h)
- Has no control over nower/electrical services at show locations but will make every effort to rectify problems as they occur and shall not
