The document included a map showing a new proposed temporary trail location at the southwest corner of Lituanica Park. This location will block the Frisbee golf course. The park board has received 11 opinions from adjacent landowners: nine opposed, one neutral, and one positive. Extensive discussions occurred from both sides of the issue and all were allowed to speak. No decisions were made. A special meeting will be held on Thursday June 30<sup>th</sup> at 6pm to walk both the Lituanica Park and Community House proposed locations.

#### **New Business**

- Brian & Theresa O'Neil will donate playground mulch in the spring of 2017.
- The new tennis court net has been a big hit.
- Rafi sprayed the park for invasive plant species such as phragmites and reed canary grass.
- The cottonwood tree next to the playground needs to come down. Rafi to get quotes.
- Can we leave the warming hut open this winter because of liability insurance? Rafi to check.
- The creation of a "Friends of the Park" group was explored. Maybe approach ABSR to see if they would be
  interested in helping park financially with projects. Maybe we could encourage friends of Park to stage a park
  gala event. Sponsors could pay for the tent, etc.

  - Appropriations: \$4,603 (BB) \$1,995 (Spent) = \$2,608 (However, town balance is -\$38,000)
