RESOLUTION #2019-41 SIGNING OF THE YEAR-END CERTIFICATION OF COUNTY HIGHWAY SUPERINTENDENT FORM 2019

Whereas: State of Nebraska Statutes, sections 39-2302, and 39-2501 through 39-2505 details the requirements that must be met in order for a county to qualify for an annual Incentive Payment;

Whereas: The State of Nebraska Department of Transportation (NDOT) requires that each county must annual certify (by December 31st of each year) the appointment of the County Highway Superintendent to the NDOT using the Year-End Certification of County Highway Superintendent form;

Whereas: The NDOT requires that such certification shall also include a copy of the meeting minutes showing the appointment of the County Highway Superintendent by their name as it appears on their License (if applicable), their License Number and Class of License (if applicable), the type of appointment, i.e., employed or under contract (consultant, or interlocal agreement with another county and/or incorporated municipality), and the beginning date of the appointment; and

Whereas: The NDOT also requires that such Year-End Certification of County Highway Superintendent form shall be signed by the County Board Chairperson and shall include a copy of a resolution of the County Board authorizing the signing of the Year-End Certification of County Highway Superintendent by the County Board Chairperson.

Be it resolved that the County Board Chairperson of Morrill County is hereby authorized to sign the attached Year-End Certification of County Highway Superintendent form.

Milo Cardenas, County Sheriff, presented the amount that it will cost to put cameras in the County and District Court rooms. The amount for both courts will be \$4,240.34 which includes labor. Travis Rodak, County Attorney, presented a Memorandum of Understanding for 2020 Community-Based Juvenile Services Aid. Schmall also asked if there could be any help from the county in fixing the rest of that road that goes into the city limits. The Board said that would be the City of Bayard's responsibility.
