BE IT RESOLVED by the Board of Trustees of Franklin Township, Franklin County, Ohio, that the Board adopts the following permit/fee schedule to become effective **March 1, 2014**

Permits /Fees

The following is the Permit/Fee Schedule adopted by the Franklin Township Board of Trustees as set forth in the 2011 Ohio Fire Code Section (E) 105 Permits, Ohio Administrative Code 1301:7-7-01.

The Fire Code Official may waive the fee when the permit is obtained by a non-profit organization or is for a non-profit function.

All contractors found working without an approved permit shall be charged twice the permit fee.

All fire protection systems and building plans must be submitted to the Franklin Township Fire Code Official through the Franklin Township Building Department. Plan review and comments are required by both entities prior to the initiation of any construction. All permits and fees must be paid in full prior to any demolition or construction. This permit and fee schedule is in addition to those required by the Franklin Township Building Department.

* All fire hydrants to be installed must be inspected by the Fire Code Official for approval.

** The permit fee covers the witness of/initial hydrostatic pressure test flush and thrust block inspections.

Tank Abandonment in Place	\$ 100.00 per tank
Tank Repair, Removal, Replacement, or Upgrade	\$ 100.00 per tank
