# Mother Nature on the Move

August 21<sup>st</sup>, 2017 – October 2<sup>nd</sup>, 2017

Glynn Visual Arts (GVA) invites members and GVA instructors in ALL mediums (2D and 3D) to apply to this fascinating show that illustrates and displays Mother Nature at her most active self. Subject matter should exhibit nature in motion. Storms, turtles coming out of a nest, ships moving through the water, birds in flight, critters on the move, undulating ocean waves, ebb and flow of tides, sunrise/sunset, fire, anything that shows nature moving and grooving.

#### General Guidelines:

- Artwork must be appropriately framed and ready to hang. No saw-tooth hangers. This means you must have at least a 5" wire across the back of your piece in order to hang it on our Walker Hanging System. Gallery wrap canvases must be painted on the sides and must be 1.25" or more in depth. THIS REQUIREMENT WILL BE STRICTLY ENFORCED.
- Artwork must be wholly original and created by the presenting artist. Works must not infringe on any rights, copyrights, trademark rights, rights of publicity, or proprietary rights of any other individual or entity. Work must have been created within the last year.
- Exhibition Committee has the right to refuse any works that are deemed inappropriate or not of good quality.

#### Submission Guidelines: **NEW! Please read carefully!**

- Artists may submit up to three pieces of art.
- All submissions must be done via e-mail to: [exhibitions@glynnvisualarts.org](mailto:exhibitions@glynnvisualarts.org)
- Subject line of e-mail should read: "Mother Nature in Motion"
- Body of email should include: Artist's Name, Address, Phone #
- Attach & send images in jpg format no larger than 72 dpi.
- Name jpg images using the following format:
  - -2017MNM"last name of artist"-"title of piece".jpg.
  - Example: 2017MNM-Ryles-BloodyMarsh.jpg
- Images must be of high quality and named properly for acceptance.
- If photos are shot on a phone please crop out all visual distractions and save in a high resolution format.

**Conditions of Exhibit:**

GVA requires a commission of 40% on all works sold. Payment to the artist/exhibitor for works sold, will be made by GVA, after a complete and accurate accounting, by the 20th of the following month. Every effort will be made to assure that the work exhibited is protected while in the custody of the GVA. However, the artist is responsible for all insurance on exhibited work.

**Publication Waiver:**

Entering artwork constitutes permission for GVA to use images and publish images of artwork as advertisement in print materials, the GVA website and other GVA social media outlets featuring the exhibition. Proper credit will be given to the artist in the event the artist’s images are used in any promotion materials.

**Terms of Entry:**

Submission of entry automatically constitutes the entrant’s acceptance of all jurying rules and criteria as stated here. Judge/jury decision is final and GVA WILL NOT entertain correspondence with respect to the results.

- Opening reception: Thursday, August 24th, 2017 from 5:30pm to 7:00pm at 106 Island Drive, SSI, GA 31522
- Artists pick up artwork Monday, October 2nd, 2017 between 9:00am - 5:00pm. **All artwork must be picked up NO LATER than October 6<sup>th</sup>** by 5:00 p.m. unless prior arrangements have been made. After October 6<sup>th</sup> the artwork becomes the property of Glynn Visual Arts.
