



Families have the option of choosing to attend Mother's Day Out Preschool and Childcare Center 2 to 5 days per week during the September - May school year. Summer enrollment will be available through a different registration form. Please choose which days work best for your family's childcare and preschool needs and we will try to accommodate them to the best of our ability. We ask that you provide us with a 1st and 2nd choice when choosing your days to help us with this process.

Our 4K program will offer a choice of a 3, 4, or 5 day schedule. Families may choose the following options which best meet their childcare and preschool needs:

**3 day options:**

Monday, Wednesday, Friday

Tuesday Wednesday, Thursday

**4 day option** must include Wednesday

**5 day option**

This program offers small class size with the emphasis on Kindergarten readiness in a hands-on approach. Results have shown students in full-day programs are hitting year-end goals faster, and developing a love of learning at an earlier age. Our 4K program will continue to offer "Handwriting without tears curriculum." Research supports the active teaching of handwriting improves creative writing skills and fine motor skills.

We will offer the following classes for your toddler and preschool child:

**Toddler Class-** child must be 1yr of age upon entry into this class

**Two's Class-** child must be 2yrs of age as of September 1, 2018

**Three's Class-** child must be 3 yrs of age as of September 1, 2018

**Pre K 4-** child must be 4 as of September 1, 2018

The before and after school care option will allow families needing full-time childcare to still have their child enrolled in our highly recommended preschool program as well as being cared for before and after school. Before School care starts @ 7:00 am and After School care would end @ 5:30pm. Please note the ending time has been extended from previous years.

Statement of Parent Cooperation- I agree to:

1. Submit a \$50.00 non refundable registration fee per child along with this registration form at the time of each child's registration.
2. Tuition will be billed weekly.
3. Payments will be made weekly either by Tuition Express, check, or Money Order. No monthly payment plans will be available.
4. Submit all the required enrollment forms on or before the first day of your child's attendance.

I understand that:

1. There will be no refund of the registration fee for any reason.
2. The center reserves the right to have a child withdrawn from the program when the center can no longer reasonably or realistically serve his/her needs
3. Failure to pay tuition on time will result in a late fee and possible release of the child from the Mother's Day Out Program.
