DESCRIPTION:

The Idaho Public Utilities Commission has an exciting new opportunity for a full-time Pipeline Safety Program Manager in Boise. This position will be responsible for the implementation and oversight of the State of Idaho Pipeline Safety program and requires extensive statewide travel.

The mission of the State of Idaho Pipeline Safety Program is to ensure the safe construction, operation and maintenance of intrastate natural gas pipelines in Idaho. This is accomplished through education, inspection, enforcement and investigation of incidents/accidents.

Candidates hired from this announcement will be eligible for up to a 5% increase in pay AND a \$1,000.00 BONUS upon successful completion of their Entrance Probation!

This position is eligible for the state benefits package, including:

- Performs scheduling on inspections, updates, and maintains Pipeline Safety Operating Plan
- Ensures program quality, integrity, and compliance with state and federal program requirements, regulations, and laws
- Administers federal Pipeline Safety Grant, including developing agreements, budgets, and providing annual reporting in FEDSTAR
- Establishes and maintains positive working relationships with staff, other programs, and department operations, stakeholders, legislature, media, the public, customers, and providers
- Represents the Commission and state at national meetings, and other specific industryrelated groups
- · Performs other duties as assigned

This position will require extensive statewide and some out-of-state travel. Incumbents may be exposed to hazardous materials and/or conditions and will be subjected to loud noise, extreme weather conditions, and exposure to construction-site hazards, natural gas explosions, and high pressure pipeline systems.



· Successful completion of PHMSA Qualified Inspector Certification

The incumbent will be required to successfully complete the PHMSA Sponsored Qualification and Training program for pipeline inspectors within 3 years of hire through a series of mandated pipeline safety courses. The first test must be passed during the entrance-probationary period and the probationary period may be extended at the Commission's discretion to accommodate additional test dates.

There is an exam to determine your eligibility. Select the option to each question that best describes your education or experience. You must have the minimum level of experience or education described for each question addressing a minimum requirement to qualify for this position. Scoring will be based on the information you provide. It is important that the option you select is supported in your resume. Your resume will be used to validate each of your responses.

- * 2. This is a Minimum Qualification question: Describe your experience managing a major program and supervising staff. This is typically met through at least one year of experience managing a major program and providing leadership and supervision of professional staff. Candidates may also qualify through completing upper-division college-level management coursework along with experience in a significant leadership role.
- * 3. MQ Specialty: Describe how you have expertise in managing and improving program development and performance. This is typically gained by at least one year of work experience in which you had the responsibility of evaluating, managing, and improving program development and performance.
- * 4. MQ Specialty: Describe your experience interpreting and applying laws and regulations relative to the natural gas industry. Include in your response your specific coursework and/or experience including dates and position(s) held. Typically, this is gained with at least one year of work experience reviewing information or documents for compliance

* 5. MQ Specialty: Do you have experience preparing oral and written reports of findings and recommendations? This is typically gained by at least one year of experience gathering information, analyzing outcomes, drawing conclusions, submitting written responses, and presenting your conclusions to stakeholders.
