### Recertification Guidelines:

- Certified individuals must submit (via CEU forms) as of January 1, 2017, 20 hours of Continuing Education Units per three year certification period OR must re-test which may be at a premium fee in addition to paying two years past dues.
- Non-IOWPA educational programs must be pre-approved by the certification committee unless noted.
- The organization must provide the individual with a 'certificate' of completion, signed by an approved representative or legible sign-in sheet. Please note that CEU program costs will vary.
- YOU MUST SUBMIT PAYMENT WITH RECERTIFICATION – the date is on your certificate:

Continuing Education Units: May be earned by attending approved education only sessions. Check IOWPA website for additional upcoming approved programs.

**Program Examples** (1 hour per wastewater topic unless otherwise noted)

- 10 max ..... IOWPA Annual Conference (5 per day per year)
- 5 max ..... IOWPA Annual Committee meeting (typically follows the conference)
- 2.5 max .... IOWPA Board/Committee Volunteers (face-to-face or conference call peryear)
- 2.5 max .... Community or volunteer/non-profit/on-site/ presentations or installations (per year)
- 5-10 max .. IOWPA Field Day (minimum of 5 and maximum of 10 per year)
- 5 max ..... IOWPA Newsletter article (per 3 year period)

IOWPA will log your attendance for all IOWPA sponsored events.
