Meeting Description

The Annual Meeting of the New England Society for Vascular Surgery is designed to provide 2.5 days of comprehensive education for the benefit of those involved in the study, treatment and cure of vascular disease.

Target Audience

It is the Society's intent to bring together surgeons, physicians, researchers, fellows, residents, students and allied health professionals from around New England to discuss their latest clinical and research findings on various topics in vascular surgery and to collaborate to construct a robust program on current controversies or topics within the vascular community.

Application Deadline

All applications for support and exhibit space must be received by Wednesday, September 15, 2021. A 50% deposit is due with completed application, with the remaining balance due by the September 15 deadline.

Meeting Registration

Exhibitor personnel must be pre-registered by **Thursday, September 30. 2021**.

Each exhibiting company is allotted two badges per tabletop space purchased. Additional badges are \$300.00 each. Each badge includes admission to the exhibit hall, scientific sessions and the Welcome Reception on Friday evening. Please Note: There will be no name swapping for badges permitted for partial attendance. Any names provided over the badge allotment will be charged the additional badge fee. No exceptions.

Exhibit Space

Each exhibit space will include one 6' x 30" draped table and two chairs. Exhibits will be tabletop only. No freestanding floor displays will be permitted. Standing equipment may be used in lieu of a table, but request must be sent in writing to the Society's Administrative Office for approval. There will be no pipe and drape. Exhibits will be located in the Cape Neddick Salon at the Cliff

Installation/Dismantling

All exhibits must be set in the Cape Neddick Salon between 3:00 pm - 6:00 pm on Thursday, October 14. Assembly of exhibits during scheduled exhibit hours (see above) will not be permitted.

All exhibits must remain intact until the official closing time of 12:00 pm on Saturday, October 16 and may not be dismantled or removed - in whole or in part - before that time. After the close of exhibits, all materials must be removed by 3:00 pm.

Space Assignment

Preferred space will be given to the Society's supporters (if application is received by the posted deadline of Wednesday, September 15). After the deadline, all other companies will be assigned in the order in which the applications with payment are received. Exhibitors wishing to avoid assignment of space adjacent to a particular company should indicate this on their application. Careful consideration will be given to such requests, but cannot be guaranteed. The NESVS has the right to alter the floor plan at any time.

Shipping Information Shipping instructions will be emailed to exhibiting companies after

the deadline.

Security

The exhibit hall will be locked when exhibits are closed, but the safekeeping of the exhibitor's property shall remain the responsibility of the exhibitor. The New England Society for Vascular Surgery and the Cliff House are not responsible for theft, loss or damage that may occur and advise each exhibitor to insure their stands, equipment and material at full value.

Conducting Exhibits

No drawings, raffles or quiz-type contests of any type will be permitted. No bags or containers for collection of samples are to be distributed by an exhibitor. This applies to any envelope, folder, portfolio, box, etc. that provides carrying space for more than a single sample. Electrical or other mechanical apparatus must be muffled so noise does not interfere with other exhibitors. Character


of the exhibits is subject to approval of the conference organizers. The right is reserved to refuse applications of concerns not meeting standards required or expected, as well as the right to curtail exhibits or parts of exhibits, which reflect against the character of the meeting. This applies to displays, literature, advertising, novelties, souvenirs, conduct of person, etc.

Liability

The exhibitor assumes entire responsibility and hereby agrees to protect, indemnify, defend and save the New England Society for Vascular Surgery, Cliff House and its officers, employees and agents, harmless against all claims, losses or damages to persons or property, governmental charges or fines and attorney fees arising out of or caused by exhibitor installation, removal, maintenance, occupancy or use of the exhibition premises or a part thereof, excluding any such liability caused by the sole negligence, gross negligence or willful misconduct of the New England Society for Vascular Surgery, Cliff House, its employees and agents. Exhibitor acknowledges that the New England Society for Vascular Surgery and the Čliff House do not maintain insurance covering the exhibitor's property and thus, it is the sole responsibility and obligation of the exhibitor to obtain business interruption and property damage insurance covering such losses by exhibitor.

Protection of Hotel


