Before joining Denton County Bass Club (DCBC) we asked that all prospective members read our club *By Laws* and *Tournament Rules* which can be found on our club website at www.dentonctybassclub.com. Our purpose as a bass club organization is to promote the sport bass fishing and lead by example by adhering to tournament ethics, conservation, and youth angling efforts to perpetuate the sport to future bass anglers. As a registered member you are expected to express a genuine interest in membership, and agree to abide by the club By-Laws and Tournament Rules.

In addition to our scheduled club tournaments, DCBC competitively fish the following venues:

- DCBC members are required to maintain 100% membership with Bass Anglers Sportsman's Society (B.A.S.S.) and register with the B.A.S.S. Nation to competitively fish State and National level events leading to the Classic.
- DCBC members voluntarily maintain membership with FLW TBF which fish the Texas TBF State Qualifier tournaments that lead to the TBF Divisionals and National tournament FLW events.

Non-Boaters:

As a tournament non-boater or co angler, you are responsible to communicate with your boater to determine how you will manage equal fishing time together in an ethical manner. Non-boater and boater provisions must be made for identifying and separating each anglers catch. Your life jacket must be worn and fastened when the combustion engine is running and the boat is under way.

Boaters complete the following:

As a tournament boater, you are responsible to comply with all boat/trailer registration and safety requirements, water navigation safety, and Coast Guard restrictions. Your boat must be designed with a functioning live well which can accommodate both you and your non-boater's catch. Boater kill switches must be attached to the driver and your life jacket fastened when the combustion engine is running and boat is under way.

Annual club membership dues shall be \$80.00, payable upon registration to the club. \$30.00 shall go to National B.A.S.S. Nation; \$25.00 shall go to Texas B.A.S.S. Nation, and \$25.00 shall be club dues to Denton County Bass Club. Membership dues are non-refundable, and each member is responsible to maintain his/her B.A.S.S. membership.

NOTE: Members joining DCBC after the month of September will only be required to pay the club membership fee of \$25.00 to participate in our remaining club tournament schedule. New members intending membership with DCBC as their primary bass club will pay the annual BASS Nation/club membership dues of \$80.00 for the next physical year.
