We will provide you with a list of approved evaluators and can make arrangements for your evaluation at the location of your choice, including all of our offices. These are done by appointment only.

#### Level I Treatment:

Multiple offenders may be required to complete an addiction treatment program. We provide Level I (outpatient) treatment at each of our offices.
