**A LOCAL LAW** Amending Local Law No. 1 of 1998 Providing for the Exemption from Taxation of Real Property Owned by One or More Persons with Disabilities

**BE IT ENACTED**, by the Town Board of the Town of Hampton as follows:

**Section 1:** Section 2 of Local Law No. 1 of 1998 is hereby amended as follows:

Pursuant to the provisions of Section 459-c of the Real Property Tax Law of the State of New York, real property located in the Town of Hampton owned by one or more persons with disabilities, or real property owned by a husband, wife, or both, or by siblings, at least one of whom has a disability, and whose income, as hereafter defined, is limited by reason of such disability, shall be exempt from taxation by the Town of Hampton to the extent provided herein:

<u>Annual Income</u>	<u>Percentage Assessment Valuation Exempt from Taxation</u>
up to 14,000	50%
14,001 - 15,000	45%
15,001 - 16,000	40%
16,001 - 17,000	35%
17,001 - 17,900	30%
17,901 - 18,800	25%
18,801 - 19,700	20%
19,701 - 20,600	15%
20,601 - 21,500	10%
21,501 - 22,400	5%

**Section 2.** This law shall take effect upon its filing with the Secretary of State of the State of New York
