#### August and November Elections Election dates are August 11 and November 3

August election will be held Tuesday, August 11<sup>th</sup> and polls will be open from 7 a.m. to 8 p.m.

If you are interested in voting absentee for the August and/or November election please be sure to get your request in early! Ballots are mailed once available and as applications are received so the earlier you apply the better!

You can request an absentee ballot by visiting <u>www.myvote.wi.gov</u> or by contacting the clerk at 608-429-3121. If you have requested ballots or an application for one and have not received it, please contact the office at your earliest convenience to get a replacement sent.

If you have moved since the last time you voted you will need to re-register. You can do this online at <u>www.myvote.wi.gov</u> or at the Village office during normal business hours. You will need your driver's license number and proof of residency.

#### Chicken Permits

The Village recently passed section 6-35 of the village code allowing up to five (5) hens, no roosters with a permit. Permit and ordinance information can be obtianed from the village office during normal business hours or requested to be mailed to you.

If you've already obtained chickens prior to approval you will also need to get a permit immediately. There is a fine for unlicensed chickens so please get your permits in. If you have any questions please contact the office.

#### Off-street parking in residential areas

Per village code section 58-160, all vehicles parked in a front yard must be on a driveway or hard surface; parking on front lawns is not allowed.

In addition, any vehicle parked anywhere on a residential lot must display current plates and be operable. Please be conscientious in your neighborhoods!

#### **Chandler Park Beach**

The Village has put a lot of time, effort and resources in to making the beach and Chandler Park even more beautiful than it already was. Please help us by keeping the new amenities in place. These items are the new swim buoys, ropes, signs, tables, and other Village property. These are not designed to be climbed on, moved or tampered with in any other way. #### HWY 22 / Main Street Construction Project

The WisDOT contractors are currently replacing curb & gutter and sidewalk along N/S Main Street at the designated locations. The bridge replacement over the Fox River bridge on HWY 22 is on a slight delay but is <u>not</u> anticipated to hold up the asphalt paving schedule. Northeast Asphalt is scheduled to start paving the north end of the County line the week of August 3<sup>rd</sup>. They should be coming through Pardeeville the week of August 10<sup>th</sup> if the bridge is completed (should the bridge NOT be completed by the August 10<sup>th</sup>, they will skip over Pardeeville and continue south with paving, return to Pardeeville once the bridge is done).

#### Permits, Ordinances, Setbacks

There have been numerous violations concerning the following Village Ordinances:

- Off street parking in residential areas
- Unlicensed vehicles on private property
- Storage of junk on property
- Allowing dogs/cats to run freely
- Barking dogs
- Unlicensed animals
- Building projects without a valid permit

The Village Ordinance Book is posted on our website. When in doubt, call the Village office.

#### Storage of junk ordinance 22-33

**Storage of junk prohibited**. No person shall store junked or discarded property including disassembled, inoperable, unlicensed, junked or wrecked motor vehicles, truck bodies, tractors, trailers, farm machinery, refrigerators, toilets, bathtubs, sinks, furnaces, washing machines, stoves, machinery or machinery parts, wood, bricks, cement blocks, or other unsightly debris for a period to exceed ten days, except in an enclosure which houses such property from public view, or upon permit issued by the village board, unless such storage is in connection with a properly licensed automotive or appliance sales, repair or storage business enterprise located in a properly zoned area.

#### IMPORTANT!!

#### Pardeeville Public Utilities will resume disconnections on past due accounts beginning on August 12, 2020. If a deferred payment agreement is needed please contact the office at your earliest convenience; before this date.

Reminder: you can pay by credit card in office, online, or over the phone utilizing the PSN payment service. There is a \$2.99 charge per transaction regardless if its online, over the phone or in office.

#### LARGE ITEM COLLECTION

The Village will have a large item collection day on Friday, September 18<sup>th</sup>. Two 20-yard dumpsters will be placed at the yard waste site off Vince Street where residents can take furniture, mattresses, box springs, carpet, couches, chairs, beds, grills, dressers, lamps, porcelain toilets and sinks.

Items **NOT** allowed: appliances (microwave, refrigerators, freezers, air conditioners), roofing and demolition material, tires, waste oil, light bulbs, fencing, lumber, ballasts, electronics (tv's, computers, radio's), 55 gallon barrels, fuel tanks.


#### **BRUSH COLLECTION**

Brush pick-up is scheduled for the following weeks:

#### Aug. 17 Oct. 12

- Pile brush at the curb pointing the cut/heavy end with the flow of traffic.
- Brush piles must run parallel with the road
- Small brush must be in an open container or CLEAR bag.
- Trim limbs per the Village Ordinance. Limbs larger than 4" in diameter or longer than 8' in length *will not be picked up*.
- Brush must be set out at the curb by Monday at 7 a.m. of the scheduled pick-up week.
- Do not set out brush more than 5 days before the scheduled Monday.
- Brush generated by tree removal contractors will not be picked up.
- Please call with questions; brush not properly stacked will be red tagged and your responsibility to dispose of.
- If you miss a collection, there is a yard waste site located off Vince St. for Village residents only!
- The Village will not pick up leaves, those can be taken to the yard waste site off Vince St.
