# **SPECIAL MEETING**

A special meeting of the Board of Pilotage Commissioners was convened at 2:55 p.m. by Chair Sheri Tonn. Present were all those attendees listed above in addition to three exam applicants by telephone.

Discuss and Consider the Simulator Evaluation Process and Results. Dr. Norman Hertz spoke of his further review of the psychometric process and analysis he applied to determine his initial recommendation of a cut score of 39. He revaluated all of the data that was obtained from the cut score study and determined that a new cut score of 36 be recommended based on further data synthesis and analysis. Motion: Mayer/Stewart — re-set the Simulator Evaluation cut score from 39 to 36 as recommended by Dr. Hertz — Carried. Based on the new cut score of 36, three additional applicants are deemed successful for a total of twelve. This scoring information will be posted on the Board's web site, sent by e-mail to all applicants, and posted at the Board Office later today. All applicants are referenced by an ID number until the entire examination and review process is complete.

**Appoint a Simulator Evaluation Review Committee.** Motion: Mayer/Marmol – appoint Captain William Anderson Sr. as the Simulator Evaluation Reviewer – Carried. The deadline for submitting a request to review was extended to Friday, April 29<sup>th</sup> at 1700 hours PDT.

There being no further business to come before the Board, Chair Tonn adjourned the special Board meeting at 3:10 p.m.
