#### **ELIGIBILITY AND HIEGHT DIVISIONS**

### **Dogs Eligible to Enter**

This trial is open to all dogs 15 months of age or older that are registered with the American Kennel Club or are register-able breeds that have obtained PAL/ILP numbers from the American Kennel Club, except bitches in season, aggressive dogs, blind or deaf dogs, or dogs suffering from any deformity, injury or illness which may affect the dog's physical or mental performance. **Mixed breed dogs** listed in the AKC Canine Partners program are eligible to enter this all-breed AKC agility trial. Mixed breed dogs entered in these events must list the breed name as "All American Dog" (mixed breed) and not as a breed hybrid and must include their AKC number on the entry form and check the AKC No. Box.

#### **Height Divisions**

The following jump height divisions shall be used in all <u>regular classes:</u>

8"	for dogs 11 inches and under at the withers	Preferred class: 4'
12"	for dogs 14 inches and under at the withers	Preferred class: 8'

16" for dogs 18 inches and under at the withers Preferred class: 12" 20" for dogs 22 inches and under at the withers Preferred class: 16"

24" for dogs over 22 inches at the withers Preferred class: 10

26" dogs may be entered at this height at owner's discretion Preferred class: N/A

#### Jump Height Information

All dogs without height cards will have to be measured by the judge of record, except 24"/26" dogs. If a VMO or an AKC Representative is available, all dogs without height cards, including 24"/26" dogs, will need to be measured. When filling out the entry form, there is a new section at the top of the form for exhibitors to designate whether your dog has a valid jump height card or if your dog needs to be measured. Please check the appropriate box so that the Trial Secretary knows whether to include your dogs on the Dogs To Be Measured List. It is no longer required that you submit a copy of your dog's jump height card with your entry form or show it during day of show check-in. 
#### Important Information for Exhibitors

- All owners and handlers are responsible for correctly entering and participating in this trial in accordance with AKC rules. Owners are responsible for errors in entry forms, regardless of who may make such errors.
- All dogs must be on leash at all times except when in the ring or when in the designated agility warm-up area. AKC does not permit pinch/prong collars, electrical or special training collars anywhere on the trial grounds.
- > The safety of dogs is of primary concern. By entering the trial, exhibitors acknowledge that they are familiar with the rules and regulations of the AKC agility program, and that their dogs are familiar with and able to perform all obstacles safely.
- Confirmation of entry and a schedule of judging time will be sent to the address (email will be used when provided on the entry form) on the official AKC entry form after the closing date. If an exhibitor has not received a copy of the schedule at least seven days prior to the show, the trial secretary should be contacted. Returned checks do not constitute a valid entry.
