



# 2019 KAW VALLEY FOOTBALL AND CHEERLEADING

The Kaw Valley Football and Cheerleading Club (KVL) is now accepting registrations for youth tackle football and Cheerleading. Space will be limited. Preference will be given to players who have previously played in KVL. Whenever possible; players will be assigned to teams according to the school or school district they attend. Final Rosters will be decided by the KVL Commissioner. All coaches will be approved by the KVL Commissioner. Most games will be played on Saturdays at the Field of Dreams located in Basehor, KS. Additional games may be played in other communities within the area. Each team will play a minimum of seven (7) league games (weather permitting). At the end of the season all teams will advance to a League Super Bowl or a Bowl game. League play will begin on September 7, 2019. The KVL will provide insurance, awards (for all players and cheerleaders), referees, ID cards, and a well maintained facility. Each player will provide their own football equipment (rental is available), mouthpiece, shoes, jersey, football pants w/pant pads and athletic supporter (The KVL will have a limited supply of equipment available to rent) The league will be divided into the following divisions (subject to Change) Flag (K-2nd Tackle will be grades 3<sup>rd</sup> grade, 4<sup>th</sup> grade, 5<sup>th</sup> grade, 6<sup>th</sup> grade. The KVL League Commissioner will rule on all issues not clearly stated in league rules. All players must have a current athletic physical (completed in 19), proof of 2019 grade and a copy of their birth certificate turned into the League Commissioner prior to the first practice. NO EXCEPTIONS! All players must have a player ID before they can play in any league games (player id is included in league fees). There will be a \$2.00 admission to all games home and away 12 and under free. The Super Bowl will be a \$2.00 admission to all games.
