

Gap Closure Contest Winners Announced!

In November, we introduced the Gap Closure Contest, an initiative aimed at celebrating and rewarding practices that go above and beyond in closing gaps in CMS-required quality metrics. The contest not only encouraged practices to enhance their quality scores but also provided an opportunity to improve patient care, all while competing for a prize pool of up to \$21,000.

Throughout the year, our Quality Coordinators work closely with practices, reviewing medical records and providing Gap in Care Reports monthly to identify patients who may be missing key elements of care. To build on these efforts and finish the year strong, the contest was held from November 1st through November 22nd, targeting several key quality measures.

Thanks to the hard work and dedication of all practices that participated, this year's contest achieved impressive milestones. Over 18% of total gaps were closed which included:

- 1,644 Fall Risk Screenings
- 124 Diabetes A1c Screenings
- 654 Controlled Blood Pressure Measurements

PREFERRED PROVIDERS – REMINDER

Preferred Providers are *not* Participants or "members" of an ACO. They are facilities and providers who the ACO has identified as experts



in their fields and whose goals and services align with the ACO's mission.

Please check the Silver State ACO Preferred Provider Network listing. The most up-to-date version is always available on our <u>website</u>, including an easily printed version.

As Medicare fee-for-service patients, the ACO's beneficiaries can go to any provider they want for healthcare services. However, we know that if the provider with whom a patient has a long-standing, respectful, and trusting relationship makes a recommendation, the patient is likely to follow it. Please help us maintain a continuum of care by referring to a preferred provider.

BENEFICIARY INFORMATION POSTERS AND NOTICES

CMS requires that every ACO Participant practice post a notification in each clinic where it sees patients. CMS wants patients to be aware that their doctor's practice is part of an ACO and what that means for their care. In addition to the poster, the practice must hand every patient a printed notice at – or before – his/her first visit of the





CMS has strict guidelines and verbiage for these notifications and does not allow practices to make any changes except to add the practice name and/or logo.

As 2025 is a new Agreement period

for Silver State ACO, every beneficiary must receive a notice at, or before, his/her first office visit of the year. (Next year, notices will only have to be delivered to newly assigned beneficiaries.) In addition, there must be follow-up communication with these patients within 180 days of the original notice. CMS is granting flexibility to practices to decide how to implement the 180 day follow up — whether in writing or verbally. CMS has not set any specifics for tracking or proof of delivery of the notices or follow-up communication. There are

currently no specific conditions or reporting requirements for either. Each practice may design its own system for keeping track of delivery, but we strongly recommend that a workflow be designed to do so, should CMS require proof in the future.

In its ongoing attempt to be sure that beneficiaries understand their rights, CMS updates their rules from time to time. Silver State ACO continues to follow notices and comments to/from CMS, and to request additional clarification, when needed. We will keep you apprised of any updates.

There are numerous templates attached to this email. First, each document is provided in both English and Spanish. (CMS makes them available in Spanish but practices are not required to post both.) In addition, each of the documents has two versions, one of which contains "without portal" in the file name. If you have a secure online portal, you want to use the other files (simply named "Poster Template" and "Beneficiary Information Notification Template"). Within the body of those documents there's reference to "ask about signing up for our secure online portal" in bold print. You certainly want your patients to know about your portal, and to use it. If you don't have a portal... you should! Those practices that do not have a portal should use the templates with "no portal" in the file name. Be sure to use the correct template for your practice.

Please be sure to complete each of the templates with your practice name where indicated at the top and the office phone number where indicated at the end of the document. Practices are required to display the current version of the poster and to use the current beneficiary information notice. CMS does not permit use of older versions of either document.

Also attached to this email are two files, developed by CMS, to help practices explain the beneficiary information notice to their beneficiaries. If you have any questions about templates or posters, please contact Rena Kantor at 702-751-0945.

The Office of Inspector General (OIG) of the U.S. Department of Health and Human Services maintains a list of individuals and entities who are excluded from federally funded health care programs. The beginning of the year is an excellent time to review your employee roster against the OIG listing, found here.
