An Ordinance

Annexing Certain Territory to the Mill Creek Water Reclamation District, Kane County, Illinois (former Schingoethe-Wennlund farm —173.385 Acres)

WHEREAS, the Mill Creek Water Reclamation is the legal owner of record of all land within the territory hereinafter described, and by and through its Board of Trustees, finds that it is in the best interest of said District that said territory be annexed to the Mill Creek Water Reclamation District; and,

WHEREAS, there are no electors residing within the said territory; and,

WHEREAS, the said territory is not within the corporate limits of any municipality or other sanitary district but is contiguous to the Mill Creek Water Reclamation District; and,

WHEREAS, all legal requirements are in full compliance with the statutes of the State of Illinois, specifically Chapter 70, Paragraph 2805/32a.1 of the Illinois Complied Statutes [70ILCS2805/32a.1 (2019)]; and,

WHEREAS, it is in the best interests of the Mill Creek Water Reclamation District that the territory be annexed thereto,

NOW, THEREFORE, be it ordained by the Board of Trustees of the Mill Creek Water Reclamation District, Kane County, Illinois, as follows:

Section 1: THAT the following described territory,

That part of the South half of the Southeast Quarter of Section 11 and that Part of the Northeast Quarter of Section 14, Township 39 North, Range 7, East of the Third Principal Meridian described as Follows: Beginning at the Southwest corner of the Southeast Quarter of said Section 11; thence North along the West line of said Southeast Quarter 745.09 feet to a South line of a tract of land conveyed by Document Number 1184412, said line being parallel with the North line of the South Half of said Section 11; thence East along said parallel line 1320.32 feet to the East line of the West half of said Southeast Quarter; thence North along said East line 576.14 feet to the Southwest corner of Mill Creek - Neighborhood Y, being a Subdivision recorded August 8, 2006 as Document number 2006K086108; thence East along the South line of said Subdivision 1323.10 feet to the Northwest corner of Mill Creek - Neighborhood W, being a Subdivision recorded May 22, 2002 as Document number 2002K066492; thence South along the West line of said Subdivision 1331.13 feet to the Southeast corner of Section 11 also being the Northwest corner of Mill Creek -Neighborhood H Phase II, being a Subdivision recorded November 13, 2002 as Document number 2002K146781; thence South along the West line of said Subdivision, 871.79 feet to the North line of a tract of land conveyed by Document number 2015K061333; thence North 87 Degrees 20 Minutes 03 Seconds West along said North line 463.77 feet; thence South 00 Degrees 49 Minutes 55 Seconds West along the West line of said tract 1441.83 feet to a point on the Center line of Hughes Road; thence North 86 Degrees 43 Minutes 03 Seconds West along said Centerline 603.89 feet; thence continuing along said Centerline North 86 Degrees 48 Minutes and 08 Seconds West 1558.07 feet to the West line of the Northeast Quarter of Section 14; thence North along said West line 2095.01 feet to the Point of Beginning, in Blackberry Township, Kane County, Illinois,

being indicated on an accurate map of the annexed territory (which is appended to and made a part of this Ordinance), is hereby annexed to the Mill Creek Water Reclamation District, Kane County, Illinois.

Section 2: THAT the District Secretary is hereby directed to record with the Recorder and to file with the County Clerk a certified copy of this Ordinance, together with the accurate map of the territory annexed appended to the Ordinance.

Section 3: THAT this Ordinance shall be in full force and effect from and after its passage, approval, and publication in pamphlet form as provided by law.


