Still need a few more votes to pass the three proposed amendments. A new ruling now requires that your MORTGAGE COMPANY needs to also sign the form in order to pass the amendment(s). The proposed amendments are:

- Association responsibility regarding trees/bushes not planted by the Developer and/or the Association.
- Nominees for the Board must be in "Good Standing," ie not in arrears, no outstanding violations, etc.
- Clarification of the Architectural (ARC) Committee's approval procedure.

PLEASE CONSIDER SIGNING FOR THE APPROVAL OF THESE AMENDMENTS AS THEY ARE IMPORTANT FOR THE COMMUNITY AS A WHOLE.

The Indiana legislature passed HB 1286, which concerns itself with Condo/Homeowner Assocations. This Bill became effective July 1, 2015. The Briar
