## Minutes of February 21, 2022

The Huntington Township Trustees met in regular scheduled session at 7:00 PM at the Township Hall. Meeting called to order with the pledge of Allegiance by Walter Rollin. Also present were Robert Holmes, Matt Combs, Jed Lamb and Sheila Lanning. Motion by Holmes with a second by Lamb to approve the minutes of February 7, 2022 as written. Roll call: three yeas. Motion by Lamb with a second by Holmes to authorize Resolution 2022-32 allowing up to \$10 million in revenue loss due to public health emergency and permitting the use of the ARP funds for government services within the Township. Roll call: three yeas. Motion by Rollin with a second by Holmes to authorize the purchase of Dennis Finkel's tools as listed for \$3,500.00. Roll call: three yeas. Rollin stated the Lorain County Township Association is sending Lyn Ickes \$100.00 related to the passing of husband, Dennis Finkel. Checks 9841-9851 and payments totaling \$9,714.05 were authorized for payment.

**WATER-** Lamb: General Mangers father passed away, three people retiring. Committee meeting Wednesday 5:30 PM to discuss personnel.

LORCO- Lamb: unable to attend meeting but nothing in the minutes that are unusual.
