Winner Guidelines

The winner of the 5 minute shopping spree agrees to the following guidelines:

- 1. Winner agrees to have their name and likeness used for advertising and promotional purposes.
- 2. Winner is not allowed to shop in store room, walk in coolers, prep areas or any other area designated by St. Clair Country Mart.
- 3. I release Country Mart and Franklin County Special Education Cooperative from any and all liability and /or injury that may occur as a result in participating in the shopping spree. This includes but is not limited to slips, falls, trips, and strains due to lifting.
- 4. Shopping spree will be on May 23, 2018 after 7pm. St. Clair Country Mart has the right to change the date and time.
- 5. No items from the shopping spree may be returned or exchanged for any reason. Items are not available for cash value. No rain checks.
- 6. Winner will shop alone and not receive any form of assistance from other person including employees.
- 7. Winner may only take two of a like kinds of meat/seafood and infant supplies. For instance, two bags of shrimp, two hams, two cans infant formula. If more than two items are taken, those items will be excluded from the total received.
- 8. The following items are not included in the spree: Medications, Gift cards, Phone cards, Stamps, Deli items, Alcohol or Alcohol related items, Tobacco or Tobacco related products.
- 9. Shopping spree will be timed for 5 minutes. Winner must have the cart returned to the register before the timer runs out. All items must be in the cart to be included.
- 10. Winner will leave the store in the same clean/organized condition as before the spree began.
- 11. Winner may have friends and family present at the time of the shopping spree. Guests need to remain at the front of the store during the 5 minute shopping spree.
- 12. Winner will have 1 cart to use for shopping.
- 13. Shopping spree winnings will not exceed the total amount of earnings raised during the raffle period.
- 14. Tickets can not be exchanged or traded. Winning name printed on the ticket is who is expected to shop.
- 15. If said winner can not be reached by phone within 48 hours of the drawing we have the right to pull a second ticket.
