WATER AND SEWER

-Baskets have been cleaned, Hydrants flushed, holding tanks have been pumped at lift stations and pum house.

-Joe/TEST has been installing lines to upgrade the control panel at the STP

-Maintenance agreements for generators at the pump house/north lift station and the STP were approved by roll call vote. All ayes.

MAINTENANCE

-Tractor will be taken in for service

-Haar will get estimate to move (2) two electrical boxes by the new sign on Rt. 89.

-Verbal estimate of \$2200 from AAA Tree Service to trim trees from Albert Avenue to the north lift station. Haar will also get an estimate from Taylor's Way.

-Water shut off in park is leaking. Keller will dig and repair.

-Light in the library foyer has been replaced. Haar would like to install a light sensor.

OLD BUSINESS

-B. Steele's office has informed Village President Edens that the collection case defendant would like to set up a payment plan to get his delinquent account paid and avoid going to court. NEW BUSINESS

-Squad car needs a new battery. Haar will purchase and replace.

-R. Campbell approved the snow removal proposal from AAA Tree Service. Cimei seconded, motion carried. \$90/hr. plus \$250/ton for salt.

-Due to an extremely large amount of unpaid water and sewer bills, the village is implementing a new delinquent/shut off policy. It has been approved that any accounts not paid in full within 60 days will be subject to water shut off with no written notice. Water turn on fee will remain \$100.

-Village President Edens will be meeting with Scout Energy concerning a wind farm project in the area. -December regular board meeting will be changed to Tuesday, December 12 at 6:30 p.m.

-Garland will be put on the black lamp posts on Main Street. 12 lamp posts will be wrapped – Haar will pick up the garland.

-A business will be notified by Sheriff's office that a trailer parked on their property is partially on the street.

-A resident has complained of getting a scratch on his truck from vehicles parked on Railroad Street.
